From the President and SUAA President

“Welcome Spring” greetings to each of you! A note of appreciation to Tech Zone for its sponsorship of the publication of this newsletter issue. Please see the included information about technology discounts for annuitants.

As your former vice president and now president, I am writing this note in November due to the production date schedule for University Marketing and Communications. Uppermost in my mind still is the sad and sudden passing of our ISUAA President Charles (Charlie) Harris on October 31. Charlie retired in 2003 as professor emeritus from the English department, after having served for 35 years, 15 of which as English department chair. He was a beloved teacher and had received the honors of being named a College of Arts and Sciences Distinguished Lecturer, as well as being inducted into the Hall of Fame. Tributes from colleagues and former students have been abundant and a comfort to Charlie’s family. In his role as president of ISUAA, he has been an exceptional leader in working with the ISUAA Board and the Annuitants Association, as well as the state association. He is sorely missed.

For this current newsletter, I have asked our former two-term ISUAA president and now statewide president for SUAA, Larry Alferink, to offer his comments along with mine in this opening letter.


Those in attendance at our December meeting enjoyed the holiday program presented by McLean County Museum of History Librarian Bill Kemp and the adjustment to our new temporary location at the Alumni Center. Please note that our March luncheon meeting will also be at the Alumni Center. April Anderson, university archivist, will present a talk entitled “The Walls Speak: Telling ISU’s Story Through its Campus Buildings.” This presentation will highlight Anderson’s recent book, *Illinois State University*, which is a part of Arcadia Publishing’s Campus History Series. From Larry Alferink: Like Charlie, I also served as a department chair for 15 years, and I think I overlapped with Charlie for about 12 of those years. He was clearly one of the leaders among the chairs in Arts and Sciences. The English department clearly benefited from his thoughtful and articulate vision resulting in a number of important developments and excellent new faculty hires. He was one of the leaders in the college in terms of the early adoption of computer technology, guiding the establishment of computer labs for teaching the introductory writing course. When I was a college freshman taking this class, I am not sure it ever occurred to me that my first draft shouldn’t be my final draft. To do a rewrite in those days was a significant chore. But once the writing assignment is done on a computer, it is an easy task to get students to rewrite that draft, perhaps after receiving constructive feedback. It is no longer a chore, and it revolutionizes the teaching of writing. It helped put the English department on the map as a national leader.


Continuing this theme, Charlie promoted the department at the annual meetings of the Modern Language Association (MLA) and brought further recognition by his work establishing and promoting the publication units (e.g., Dalkey Press) of the department: units that brought national recognition to the department due to the quality of the work they published. Finally, Charlie established the Doctor of Arts degree (now the Ph.D. in English). Gail wrote about his leadership role in ISUAA, and I second her comments. Charlie will be missed!

I am also sad to report the passing of Tom Wilson, a faculty member in political science (now the Department of Politics and Government). Tom was an early leader for the annuitants, serving as chair or co-chair of the ISUAA Legislative Committee and serving the same role for SUAA statewide. Tom made many trips to Springfield to work with members of the legislature and worked to increase the very low pensions of many of our members at that time.

Finally, we both hope to see you at our March 7 luncheon at 11:30 a.m. at the Alumni Center.

How time flies

150 years ago - 1868

- At the June 1868 board meeting, the following salaries of university administration were proposed and adopted:
 - President Edwards, \$4,000 per annum
 - Professor Sewall, \$2,000 per annum
 - Professor Metcalf, \$2,000 per annum
 - Professor Stetson, \$2,000 per annum
 - Professor Pillsbury, \$2,000 per annum
 - Miss Dryer, \$1,100 per annum
 - Mrs. Haynie, \$900 per annum

100 years ago - March/April, 1918

- *The Vidette* reported coal shortages and four scheduled school day closures. The closures were planned by university administration in response to World War I. *The Vidette*, March 6, 1918 (Vol. 30, No. 24, pg 1).
- The university announced that the surgical dressing shop was open Mondays and Fridays and needed help creating supplies. Students and faculty were encouraged to help as well as men: "Men can help as well as women. In a number of the larger cities of Illinois the business men meet one or two evening a week and do this work." *The Vidette*, March 27, 1918 (Vol. 30, No. 26, pg 5).
- Grammar teacher, Clara Penstone, announced her departure from the university at the end of the spring term. She was undecided at the time but Penstone considered studying at Columbia University and serving with the Red Cross during World War I. *The Vidette*, March 27, 1918 (Vol. 30, No. 26, pg 1).

75 years ago - March/April, 1943

- Army officials contacted President Fairchild to activate the Army Enlisted Reserve Corp. Seventy-two men were called in three groups to camps in Michigan and Illinois. *The Vidette*, March 5, 1943 (Vol. 55, No. 35, pg 1).
- The YWCA campus affiliate launched a restoration effort of their meeting room, The White Room in Old Main. The affiliate also acknowledged their place in history as the first student YMCA organization in the world, founded in 1872. *The Vidette*, March 17, 1943 (Vol. 55, No. 37, pg 3).

- Assistant Librarian Genevieve Pohle opened a historic encyclopedia exhibit. The exhibit featured rare encyclopedias with accompanying histories about some of the authors of the encyclopedia's entries. *The Vidette*, March 26, 1943 (Vol. 55, No. 39, pg 4).

50 years ago - March, 1968

- Acclaimed journalist Peter Jennings was chosen to be the featured speaker for the ISU/IWU Leadership Conference on April 20. Held at ISU, Jennings's talk was titled "Leadership for the Future." *The Vidette*, March 12, 1968 (Vol. 80, No. 48, pg 1).
- *The Vidette* featured a photograph of the empty lot where the new University Union would eventually be located. As reported, the construction had not yet started due to building redesigns and construction bids that were behind schedule. *The Vidette*, March 14, 1968 (Vol. 80, No. 49, pg 1).
- With the play *Revelation*, chamber theater was introduced to ISU. Written by Flannery O'Connor and adapted for the stage by ISU assistant professor of speech, Dr. Hauseman, the play showed audiences how the space was used as "a medium for staging prose fiction." *The Vidette*, March 26, 1968 (Vol. 80, No. 352, pg 1).

25 years ago - March, 1993

- Voice actor Billy West made an appearance at the Bone Student Center on March 3. Best known for his work on the 1990s cartoon, *Ren & Stimpy*, West talked about his background in acting and the inspirations behind his most famous characters. *Mollycoddle (The Daily Vidette)*, March 17, 1993 (Vol. 105, No. 122, special section 3, 6).
- Student government presidential candidate Jim Hoffmann purchased commercial time on MTV to express his views on politics and governing at ISU. The First party candidate aired commercials the week leading up to the March 30 election. *The Daily Vidette*, March 25, 1993 (Vol. 105, No. 127, pg 3).
- Alvin Goldfarb was selected to receive the Illinois Alliance for Art Education Serve Recognition Award. He was nominated by John Langfeld, director for the Illinois Summer School for the Arts. Langfeld cited Goldfarb's support for the program and how his input in a time of state budget cuts helped the program retain its quality of education. *The Daily Vidette*, March 26, 1993 (Vol. 105, No. 128, pg 5).

Future challenges

As president of SUAA, I attend a number of fundraisers for candidates running for the Illinois legislature and for statewide office. In addition to offering the opportunity to establish a relationship with

the candidates, I also get to meet with a number of other candidates who attend these fundraisers. These contacts often prove useful in the future.

One sometimes gains information about legislative agendas. Such was the case at a recent fundraiser attended both by House Minority Leader Jim Durkin and Gov. Bruce Rauner.

Durkin indicated he intended to pursue the pension bill that follows the consideration model. I previously described this bill last year in a newsletter. In short, the bill is based on the premise that the Constitution does not protect future pay raises. Because of this, it is argued, the state could give you a choice that would allow you to receive future pay increases as an employee only if you agreed to reduce the 3 percent COLA increase in retirement. This consideration model was part of the "grand bargain" in last year's budget battle. We need to be vigilant to watch how this progresses, attempt to defeat it in the legislature, or if that fails, consider going back to court to defend the pensions of current employees.

Rauner continues to pursue his efforts to have Congress intervene in helping him solve the state's pension debt issue by overriding the constitutional protections that exist for your pensions. This effort would affect future pensions of current employees as well as the pensions of annuitants. The governor seems to be focused on using Congress to eliminate what he considers to be the most significant pension abuses. However, without legislative language to analyze, it is difficult to know where the line is that separates "abuses" from pension benefits you have clearly earned.

It is unlikely that Congress will interject itself to override the 1970 vote by Illinois voters that approved the state's constitution, or a similar vote by citizens to defeat an amendment to the pension clause a few years ago, and a unanimous Illinois State Supreme Court decision upholding the pension clause against legislative attack. However, should that occur, it would likely require an effort to defeat such efforts in federal courts. Such legal battles are likely to be even more expensive than the successful effort to defeat SB-1 in the Illinois Supreme Court.

Stay tuned for future attempts to amend the Illinois Constitution.

Leaving a legacy

Sandra Groves, a retired professor in the School of Kinesiology and Recreation, has supported Illinois State University for decades. With the launch of Redbirds Rising: The Campaign for Illinois State, Groves has turned her attention toward mobilizing faculty and staff to contribute.

“It is important to participate,” Groves said. “Participate not just by giving your money, but by becoming part of institutional traditions. That level of participation will increase your commitment. And the institution will be committed back to you.”

Groves spent her early career in municipal and county park and recreation agencies throughout Illinois and Kansas, before being led into higher education. She moved to Pennsylvania from Illinois to be an instructor at Penn State University. Being successful at teaching, Groves was encouraged to earn her Ph.D. at Penn State and become a faculty member. Upon completing her doctorate, she returned to Illinois to become an assistant professor at Illinois State University.

Groves started giving back to Illinois State from the start. Giving early started a process where she was able to identify specific places of need at Illinois State and make a greater impact on those issues later on in life.

While at Illinois State, Groves was a graduate coordinator for Kinesiology and Recreation and often found herself assisting graduate students with tuition waivers and identifying other sources of funding. As part of her retirement, fellow faculty members started *The Sandra Little Groves Graduate Student Emergency Assistance Endowed Fund* in 2008, which awards money to graduate students who need financial assistance.



Groves enjoyed meeting the students her scholarship supported. Seeing the impact of her philanthropy encouraged her to seek out additional ways to support her passion at Illinois State.

In 2014, Groves launched *The Sandra Little Groves Recreation and Park Administration Faculty Development Fund*. The fund supports faculty development opportunities for the School of Kinesiology and Recreation’s Recreation and Park Administration program. The philanthropic dollars have been used to help faculty with establishing a research agenda as they pursue promotion and tenure.

For faculty and staff just starting out, Groves recommends starting small. Often the best place to start is within your own unit on campus.

“I am happy that I responded to my department’s call to give,” Groves said. “That is the best place to start as that money goes right back to supporting your students and fellow faculty.”

Groves is excited about the timing of Redbirds Rising.

“There are so many positive things going on for Illinois State,” Groves said. “The leadership at the institution, strong enrollment, new opportunities ... a whole variety of things have risen. This campaign is part of that continued rising process and to bring that to the forefront for more people.”
