First, a big thank you to Tech Zone for once again financially sponsoring the publication of this newsletter issue. Please see the included information about technology discounts for annuitants. We are very appreciative! Note also on page 3, the SUAA update from Larry Alferink— information is included regarding the potential organizational structural changes for SUAA. SUAA leadership is indicating that the current year will be filled with interest statewide, with the new governor in place along with many new legislators.

Our ISUAA Board and Membership Committee are working diligently with several initiatives to make our organization more prominent in the eyes and awareness of current employees, retirees, and potential new members. We have launched a Membership Drive for spring semester which included an email blast to all employees in January, giving them information about ISUAA and benefits of membership. Following this endeavor, we sent a mailing including a letter of invitation and a membership form to each of the 3,500 employees at the University. How Time Flies

150 years ago – 1869

- At the meeting of the Board of Education, second university president, Richard Edwards, gave his annual report: “The present condition of the University is so nearly the same as it was one year ago, that it seems hardly necessary to make a full statement of it. We have raised, somewhat, the standard of scholarship since that time, but with no diminution in our numbers. All the members of the long-tried faculty are retained, and the increase of appropriation made by the last legislature has enabled you to add two to the number. Of the former instructors nothing need be said. They are thoroughly known to you, and their efficiency has been tried. But of the two last appointed a word may be appropriate. And it gives me pleasure to bear unqualified testimony to their faithfulness and efficiency. Their labors have been in a high degree satisfactory to all concerned, and they enjoy the respect and esteem of the students. It is the determination of the entire board of instructors to give the institution as high a degree of efficiency as they possibly can, and with the present increased facilities they have good hope of increasing materially its usefulness and fame. All of which is respectfully submitted.” *Proceedings of the Board of Education of the State of Illinois, Meeting Minutes, December 15, 1869, pg 3-4.*

100 years ago – January–April, 1919

- Professor D.C. Ridgley, a geographer, left for an estimated eight-month journey to Europe to teach geography to soldiers in the American Expeditionary Forces. At the time of his departure, Ridgley was given a send-off from colleagues and students alike as well as “a number of small packages which had been prepared by his friends, one to be opened on each day of his trip across the ocean.” *The Vidette*, January 1, 1919 (Vol. 31, No. 13, pg 1).
- During Founders Day exercises, one of the surviving graduates from the first graduating class recalled the first commencement in 1860. Mrs. M.L. Christian recalled that each graduating student, six men and four women, gave an exercise in what was later used as a study room in Old Main. The room was “crowded” as “farmers for miles around stopped their work and drove with their families to attend the grand event.” Later, a dinner was held in what became known as Normal Hall, and the graduates sat at a table with many of the individuals who helped to found the institution. *The Vidette*, March 5, 1919 (Vol. 31, No. 22, pg 1, 4).
- The Illinois State Teachers Association held its annual meeting at ISNU on April 11-12 with great success. Almost 2,000 new members were enrolled, and many programs were led by “first-class talent.” The theme for the meeting was “derived from the great topic of the hour, namely reconstruction; opportunities and duties; the way and how from the standpoint of education.” *The Vidette*, April 16, 1919 (Vol. 31, No. 27, pg 1).

75 years ago – January–April, 1944

- Brokaw Hospital asked the students of ISNU to volunteer to help prepare vegetables for patients at the facility. The hospital cited a “shortage of help” and through the Student War Services Committee asked for two female volunteers a day “to help prepare vegetables for hospitalized cases.” The volunteers were asked to wear a smock or an apron and that “Those who wish to bring their own paring knife may do so.” *The Vidette*, January 14, 1944 (Vol. 56, No. 14, pg 2).
- The Philadelphians beat the Wrightonians in the 83rd annual Phil-Wright contest. The Philadelphians also broke a two-year winning streak by the Wrightonians and gave themselves an overall win total of 43 to the Wrightonians 37. The Philadelphians won several of the night’s competitions as well as the debate that was presided over by President Fairchild. *The Vidette*, February 23, 1944 (Vol. 56, No. 18, pg 1, 3).
- The ‘Tune Detective,’ Dr. Sigmund Spaeth was scheduled to appear Thursday evening, April 20 in Capen Auditorium. His lecture, “America’s History in Song” was described as “a musical index to the habits, costumes, manners, morals, and slang of our picturesque past.” Known for his NBC program, *Tune Detective*, Spaeth was a composer, editor, lecturer, and music critic who traveled to “camps, hospitals, and canteens” during World War II to entertain the troops. *The Vidette*, April 19, 1944 (Vol. 56, No. 25, pg 1,4).

50 years ago – February–April, 1969

- Five professors with a combined 105 years of university service announced their retirements. They were: Alice O’Brien Harris, assistant professor and supervising of the primary educable mentally handicapped; Ruth C. Huggins, associate director of University High School and assistant professor of English; Eldon A. Lichty, professor of education of the junior college of curriculum; Irving W. Salowitz, director of health services; and Raymond W. Tudor, assistant professor of English. All were scheduled to retire on August 31. *The Vidette*, February 6, 1969 (Vol. 81, No. 35, pg 1).
- Rev. Andrew Young, vice president of the Southern Christian Leadership Conference and associate of the late Dr. Martin Luther King visited campus March 18 and 19. Young delivered the talk “Civil Rights and the World, 1969: Dawn or Doom” at both Capen Auditorium and Linkins Center. In addition to speaking with students, Young also attended a sociology seminar. *The Vidette*, March 25, 1969 (Vol. 81, No. 48, pg 1).
- Ten faculty members were chosen for the Robert G. Bone Distinguished Teacher Award. Chosen by a committee of students, the 10 recipients were: Ellen Abshire (health and P.E. for women), Clinton Bunke (education), Kenneth Fitch (anatomy), William Frinsko (education), William Gnagey (psychology), Dorothy Jacobs (English), James Patterson (geography), Herbert Sanders (music), David Wheeler (geography and assistant dean of students), and William Zeller (education). *The Vidette*, April 24, 1969 (Vol. 81, No. 53, pg 1).

25 years ago – January–March, 1994

- The Music Department and the College of Fine Arts co-sponsored a weekend workshop for area elementary school students called, “Learning to Live as One.” The workshop taught African American history “through the use of arts and crafts, songs and games.” *The Daily Vidette*, January 21, 1994 (Vol. 106, No. 87, pg 6).
- Virginia Lee Owen was one of two Americans elected to the board of trustees for the Association for Cultural Economic International, an association that studies the economics of the arts. Owen, former dean of the College of Arts and Sciences and professor of economics, would be responsible for “reviewing financial operations and management questions,” “hiring a secretary-treasurer of finances and approving plans for the association’s conference.” Owen would serve a three-year term. *The Daily Vidette*, February 7, 1994 (Vol. 106, No. 98, pg 6).
- The College of Arts and Sciences Distinguished Teacher Awards for 1993 were announced. The five faculty honored included Mary Campbell (social work), Tom Shilgalis (mathematics), James Van Der Laan (foreign language), James Stanlaw (sociology/anthropology), and Ron Strickland (English). The CAS Outstanding Researcher Award was given to two recipients: Ram Singh (economics) and Michael Gorr (philosophy). *The Daily Vidette*, March 2, 1994 (Vol. 106, No. 115, pg 2).

Fall 2018 SUAA board meeting

The SUAA Board of Directors met on October 30 at the Illinois State Alumni Center for the Fall Board Meeting. The meeting began with a presentation by John Novack, an attorney and an expert on not-for-profit organizations. After covering basic points of the responsibilities of board members, he noted that most boards consist of fewer than 20 members. He had never seen a board as large as SUAA’s, with 100 or more members present at any given meeting. Noting that it is prohibitively expensive for organizations to obtain officers and directors insurance for such a large group, that SUAA directors probably are not insured and would be liable for any legal action that arose as a result of any decisions they made. Linda Brookhart indicated that the members of the executive committee were insured, but to cover all members of the board would cost over \$1 million. More on this later.

The board also heard a presentation by Kent Redfield on why the state is in such financial difficulties. This was a shortened version of the presentation he gave as part of the ISU Academy of Seniors. Curtis Oldfield, president of Spoon River College was the luncheon speaker; his talk was the “Future of Higher Education in Illinois.”

The board approved a budget for 2019 that was largely identical to the budget for 2018, with some adjustments for cost increases such as office rent. Given that the size of the membership has de-

clined to about the same as it was approximately 10 years ago, SUAA faces budgetary challenges. The tentative solution for this year is to activate a budget line for donations, a line that has been inactive for the past several years. A basket for donations did yield several hundred dollars at the meeting. A total of around \$3,000 will be needed over the course of the year.

The board also approved a significantly reorganized and revised legislative platform. In particular, past legislative platforms listed our support for the re-amortization plan to pay down the pension debt proposed by the Center for Tax and Budget Accountability (CTBA). The current platform specifically supports the bond plan proposed by SUAA and notes that there are several other proposals that may merit our support, without naming CTBA. Supporting a proposal by naming the organization that proposed it might cause that proposal to be changed to something we don't support. This revision eliminates this problem while allowing our support of an appropriate proposal.

I earlier noted that John Novack had indicated that SUAA has an unusually large board of directors. At the end of the meeting, Chuck McGuire introduced a motion charging the bylaws committee to develop bylaws amendments changing the board to a House of Delegates that would not have the authority to set policy or approve motions for which they would have legal liability. With an amendment temporarily increasing the size of the bylaws committee to work on this task, the motion was approved.
