How time flies

150 years ago - 1869

• Jesse W. Fell reported that the Bloomington and McLean County Coal Companies made bids for supplying the university with fuel for the coming year. Fell purchased the fuel and cords of wood for a total of \$614.54. Fell was also in charge of improving the campus sidewalks, including the route between the City of Bloomington and the university. The funds provided were to either repair the existing sidewalk or replace it entirely. Lastly, Fell reported on the trees planted the previous year, having introduced to the Quad "107 deciduous ornamental trees, ranging in size from three to five inches in diameter, and 1010 evergreens, ranging in hight (sic) from five to fifteen feet." Proceedings of the Board of Education of the State of Illinois, Meeting Minutes, December 15th, 1869, pages 4-6.

100 years ago - June, 1919

- The Vidette gave helpful tips to summer school students on how to navigate their first days on campus. These directions included checking handbags in Room 11 of the Administration Building (later known as Old Main), secure room and board with either Miss Barton (Dean of Women) or Mr. Linkins (Dean of Men), guides to the building and the campus were to be located on the north porch of the Administration Building, "Keep to the right" and no conversation when in the halls of the Administration Building, and "Move rapidly from class room to class room especially to and from General Exercises." The Vidette, June 7, 1919 (Vol. 31, No 34, page 1).
- The university celebrated the return of its service members from the Great War: "From 3 o'clock in the afternoon until half after midnight we celebrated. Beginning with a reception in the gymnasium, there followed a supper at Fell Hall, then the play and last the dance. Only those who have been on the campus during the last two years can realize fully just what the sight of familiar faces meant and grasp the significance of seeing 'our Own' return." *The Vidette*, June 16, 1919 (Vol. 31, No 35, page 2).
- A call for students to enroll in vocation education courses was announced in *The Vidette*, with instructors in Commerce, Manual Arts, and Agriculture. Men who performed these tasks in the Great War were given as examples of those who

Horton Tatmam was a ship carpenter, Grover Johnson was a mechanic, and Robert Sanford, "was sent to France as a wood-worker to repair air planes." *The Vidette*, July 14, 1919 (Vol. 31, No 39, pages 1-2).

75 years ago - June, 1944

- During World War II, *The Vidette* included a feature written by the Navy V-12 called "Scuttlebutt." In the feature, quirky and colorful news of the campus-based naval unit would be shared. Among the announcements, a nomination for "Idol of the Campus" for that week was announced as Frank Olivieri (the author questioned the spelling of the last name), and proclaimed, "From a reliable source comes the Scuttlebutt that he is strictly THE Sailor, where women are concerned." *The Vidette*, May 3, 1944 (Vol. 56, No 26, page 4).
- The university announced that with the start of summer term, every Wednesday night would be "playnight on the south edge of campus" with activities such as "volleyball, badminton, tennis, croquet, ping-pong, shuffleboard, and archery" for two hours. *The Vidette*, July 12, 1944 (Vol. 56, No 32, page 1).
- President Fairchild announced eight new faculty members who would join the campus: Dr. Esther L. French (Health and Physical Education), Miss Bernice Cooper (Health and Physical Education), Arley F. Gillette (Health and Physical Education), Miss Ruth Lambertus (Instructor of Music), Dr. Lenor Geweke (Foreign Languages), Miss Ruth L. Cole (Supervising Teacher, Metcalf 2nd Grade and Instructor in Education), Dr. Claude M. Dillinger (Psychology), and Louis Hoover (Director, Art Education and Head of Art Department). The Vidette, July 26, 1944 (Vol. 56, No 34, pages 3-4).

50 years ago - July, 1969

- Two administrative interns from Kenya, David M. Mbiti and James K. Wainaina lectured on how to "solve teacher education problems such as decisions in curriculum and facilities." The interns worked on ISU's campus for a year and directly with Charles Edwards and Eric Johnson in the Department of Educational Administration. *The Vidette*, May 6, 1969 (Vol. 81, No 56, page 1).
- G.K. Roderick earned his degree in elementary education, thirty-nine years after he earned his two-year teaching certificate in 1930. After taking extension classes over the years, he lived in Manchester Hall for his final semester. *The Vidette*, May 8, 1969 (Vol. 81, No 57, page 2).
- After a 112-year ban, President Braden lifted restrictions on the establishment of social sororities and fraternities. Braden said the university would, "neither encourage nor discourage students from forming or joining such organization, nor will it accord fraternities or sororities any status which would involve or suggest approval, regulation or support." The Vidette, July 1, 1969 (Vol. 82, No 1, page 1).

25 years ago - June, 1994

- Parking Services prepares for the closure of the Julian lot as Facilities prepares for the construction of the new science complex. Primarily used by faculty and staff, Bill Waller of Parking Services recommended those who normally park in the lot to relocate to the School Street Ramp, in F36 near Centennial, or in F67 north of the Baptist Church. Summer Vidette, June 22, 1994 (Vol. 107, No 1, page 3).
- The Illinois Shakespeare Festival returned with three shows: *Romeo and Juliet*, 1 Henry IV, and Two Gentlemen of Verona. After-show discussions and a lecture series would feature theatre faculty and actors who would "provide background support on the history plays" as well as "cover social aspects of the times." Summer Vidette, June 22, 1994 (Vol. 107, No 1, page 9).
- The long-time party house known as The Inferno was torn down to make way for a new apartment complex. Popular through the 1980s, the house was known for hosting live bands and several beer kegs for party guests. Named by residents in 1988 whom all had separately experienced fires at their previous residences, The Inferno was host to local bands including Don Futon, Joyhammer Mopweed, Liquid Eyeball, and Crank and Phydeaux. Summer Vidette, July 6, 1994 (Vol. 107, No 3, page 3).

Proposed bylaws change to be voted on at annual business meeting

The ISUAA Executive Board has proposed important changes to our bylaws. To be adopted these changes must receive a two-thirds vote of those voting at a regular meeting of the chapter. Please go to our website Annuitants.IllinoisState.edu to review the changes—the link is on the front page, under "Announcements." In summary, the changes include the following:

- Simple word changes to be consistent with SUAA bylaws wording. (use of the word "bylaws" instead of "Constitution"; use of "SUAA" instead of "State Association."
- Broader definition of "members" to be consistent with the SUAA bylaws.
- Recommendation to increase number of ISUAA chapter directors from four to seven. The three additional members would be elected from current employees who are ISUAA/ SUAA members—elected by the Academic Senate, AP Council, and Civic Service Council, one from each employment category.
- Continuing: The president and vice president shall serve no more than two consecutive terms in the same office.
- Eliminating: the restriction for number of terms of the secretary and treasurer.
- Clarification of dues payment.

Illinois Shakespeare Festival celebrates literature with 'a fresh look at classic stories'

The Illinois Shakespeare Festival's (ISF) 42nd season will showcase theatrical comedy, sparkling romance, and political drama. Inspired by the theme of "a fresh look at classic stories," this summer will feature adaptations of three well-known favorites: William Shakespeare's *As You Like It* and *Caesar*, and Jane Austen's *Pride and Prejudice*. Join us June 27–August 10, 2019.

The season opens with a Shakespearean favorite, *As You Like It*. The production will be set in the early 20th century and include original music composed by veteran ISF actor Jordan Coughtry. In this joyful comedy, Rosalind and Orlando fall in love at first sight, but are forced to flee the dangers of the court. Disguised as a young man, Rosalind teaches clumsy Orlando the way to a woman's heart—hers, to be exact. The young lovers escape to the forest of Arden and delight in luscious nature, love, life, companionship, and song ... until Fortune makes everything right again.

Deanna Jent, who directed last year's *Merry Wives of Windsor*, will return to bring the timeless classic *Pride and Prejudice* to the stage. Life was pleasantly drab for Elizabeth Bennet until the haughty (though admittedly handsome) Mr. Darcy barged in on her life. Now she's caught in a dilemma: Can Elizabeth be true to her feelings while also standing up to Darcy's arrogance? This lively adaptation of Jane Austen's beloved novel persuades us that even the worst first impressions can be overcome.

As You Like It and Pride and Prejudice will be performed outdoors at the beautiful Ewing Theatre.

Caesar is a dark drama adapted and directed by veteran ISF actor Quetta Carpenter. Julius Caesar's days are numbered in this mediasaturated, modern take on Shakespeare's classic tragedy. With Caesar's assassins in one camp and the inheritors of his authority on the other, political warfare consumes Rome—fought through social media and the 24-hour news cycle. Who will survive in the end, and will they still be themselves? See the story in the air-conditioned comfort of the Center for the Performing Arts Theatre on the Illinois State University campus.

New program from the SUAA Foundation

The SUAA Foundation, established in 1989, is authorized to support education and dissemination of information on issues affecting the welfare of SUAA members, provide emergency assistance grants to chapters that support members facing financial crises, and assist chapters in providing survivor assistance programs. This summer the SUAA Foundation is establishing a scholarship program for members, their spouse/partner or child or grandchild. The foundation will offer up to four scholarships of up to \$500 each annually. Scholarships will be awarded for use in accredited degree-seeking programs, eligible technical/trade programs, eligible certificate programs, or for professional development. SUAA legislative platform for 2019

This legislative platform serves as a general guideline for SUAA's positions on legislation that affects pension, health insurance, and other retirement benefits for SURS participants.

The main legislative goal for 2019 is to protect the retirement security of all past, present, and future employees of Illinois' public universities, community colleges, and their survivors.

SUAA will review and evaluate all proposed initiatives and legislation relating to pensions, other retirement benefits, and the maintenance of a robust higher education system to determine their compatibility with the association's goals. As appropriate, SUAA will publicly support or oppose such initiatives and legislation either in part or in their entirety.

If legislation is enacted that SUAA considers to be in violation of the pension protection clause of the Illinois Constitution, SUAA is prepared to challenge that legislation in the courts in concert with coalition partners or if necessary independently.

2019 legislative action plan

- SUAA supports legislation that provides for guaranteed full funding of the SURS pension system.
- SUAA opposes any legislative attempt to amend, modify, or eliminate Article XII, Section 5 of the Illinois State Constitution which states: "Membership in any pension or retirement system of the state, any unit of local government or

school district, or any agency or instrumentality thereof, shall be an enforceable contractual relationship, the benefits of which shall not be diminished or impaired".

- SUAA opposes legislation that does not provide for a compounded automatic annual increment that provides protection against inflation.
- SUAA opposes legislation designed to eliminate the defined benefit option in state retirement plans for future employees.
- SUAA supports legislation to revise Tier II pensions for a more equitable set of benefits related to final salary period, automatic annual increment, and early retirement reduction. SUAA will also closely monitor efforts to implement Tier III pensions.
- SUAA opposes the 3 percent cap on earnings during the final four years of employment. SUAA supports increasing the cap from 3 percent to 6 percent as an interim improvement.

Revenue enhancement measures

It is SUAA's position that in order for the state to meet its current budget obligations, make full annual payments to the various pension systems, and pay down the existing pension debt, the legislature will have to implement measures to increase state revenues and/or produce savings.

SUAA continues to support its proposal for using pension obligation bonds to fully or partially pay down the pension debt, but SUAA recognizes there are several other potentially viable options to address the pension debt. SUAA is open to support any of these options or package of options that, if implemented, will result in moving the state toward full funding of its pension systems.

A key condition for SUAA support of any pension-related initiative or package of initiatives to increase state revenues or result in a savings to the state is that a portion of all resulting increases and/or savings must be dedicated to reducing the state's pension debt.

SUAA supports other revenue-enhancement measures not directly related to pension debt that would address the state's continuing fiscal crisis. These measures include but are not limited to: the taxation of selected services, a speculation sales tax, and the elimination of some tax breaks such as the foreign dividend exemption, offshore oil drilling credit, and retail sales tax discount.

Health insurance

SUAA supports legislation to ensure that all Illinois public university and community college employees, retiree and survivors will be treated equitably under the State Employees Health Plan and College Insurance Programs.

SUAA supports full funding for the College Insurance Plan, and SUAA opposes any reduction in coverage provided by that plan.

Federal legislation

SUAA supports the repeal of the Social Security Windfall Elimination and Pension Offset.

Preserving the quality of higher education

Recent trends and threats to the state's colleges and universities are of concern to SUAA membership.

- SUAA opposes legislation to reduce or eliminate the 50 percent tuition waivers for the children of current employees at state universities.
- SUAA opposes legislation to "reform" higher education by establishing "Centers of Excellence," setting uniform university admission requirements, eliminating programs/majors, severely limiting programmatic expansion, and changing the Illinois Board of Higher Education to be a governing body.
- SUAA opposes the consolidation of the Illinois Board of Higher Education, the Illinois Community College Board and the Illinois Student Assistance Commission with all their rights, powers, duties, and functions to be transferred to the IBHE.
- SUAA opposes prohibition of nonessential expenses for FY 2019, 2020, and 2021, which includes all promotion and advertising and travel expenses.
- SUAA opposes legislation that would create a three-year teaching degree.
