How time flies

150 years ago - 1873

Before Angeline Vernon Milner, a "chief librarian" managed the loan and use of a small Reference Library for the campus. Along with the chief librarian, there were three assistant librarians, all of whom were responsible for the care and use of the materials. In lieu of the chief librarian, who had "school duties," the assistant librarians primarily oversaw the use of the materials in the Reference Library. When patrons requested use of the materials, "every person consulting a book writes his name in a blank book kept for the purpose, and the attendant librarian enters opposite to it the name of the book he desires to consult." While the board allowed for \$50 to pay for library salaries, ISNU paid the chief librarian \$100 a year and \$5 per term to each assistant librarian. President Edwards argued this amount was not nearly enough: "I do not think it possible to secure the right performance of the duty for less than the sum first named."

100 years ago – Sept.-Oct. 1923

- The Jesters, the ISNU dramatic club founded in 1910, announced a special meeting to elect officers for the group. To be a member of the Jesters, a student of either ISNU or University High School must try out and be selected for the annual Jester play performed at Homecoming. Potential members can also have performed in a play at ISU or University High School. Once the show is complete, actors are then elected by the Jesters into the club. *The Vidette*, September 8, 1923 (Vol. 36, No. 1, pg. 2).
- Librarian Angeline Vernon Milner set out a new plan for borrowing periodicals from the library: "The latest number of the monthly *Current History* and the weekly *Literarly Digest* are to be kept in the reading room until after 9 p.m. The current numbers of all other magazines are to be given out at 5 p.m. if wanted then. All will be due before 8:30 a.m. and should be returned as near 8 a.m. as possible for the accommodation of other readers." *The Vidette*, October 3, 1923 (Vol. 36, No. 4, pg. 2).
- The third annual Homecoming took place on October 26-27, 1923. The main events were football games between University High and Normal Community High and ISNU and Blackburn College. The popular waffle breakfast returned along with a Hobo parade, club meeting lunches and dinners, and the all-school party and dance from 8:30 p.m. to 11 p.m. at both the gymnasium and Fell Hall. *The Vidette*, October 10, 1923 (Vol. 36, No. 5, pg. 1).

75 years ago – Aug.-Oct. 1948

• With the recent passage of Public Law 796 and signed by President Truman, the transfer of ownership of Cardinal Court to the state of Illinois and ISNU was imminent. While ISNU did not need to pay the federal government for the buildings, preference for unit rentals to veterans would continue. At the time, all 85 apartments were occupied with a waiting list. *The Vidette*, August 4, 1948 (Vol. 61, No. 5, pg. 1).

- Incoming students were invited to the first annual Tomato Festival, sponsored by the Normal Chamber of Commerce. The festival highlighted "the fame of Normal as the major tomato packing area in Illinois" and offered a football game, cooking demos, and a soapbox derby. A dance was also offered at 9:30 "so that students might attend the annual church parties held earlier that evening." *The Vidette*, September 14, 1948 (Vol. 61, No. 8, pg. 2).
- The 27th annual Homecoming was held on October 21-23, 1948, and featured several alumni gatherings, dances, parades, and the annual football game. *The Vidette* reviewed past homecomings with the headline, "Annual Reunion Recalls Decade of Two-Bit Steaks." *The Vidette*, October 21, 1948 (Vol. 61, No. 13, pg. 1).

50 years ago – Aug.-Oct. 1973

- Roar Schaad, an instructor who taught an introductory course in electronic music, was set to perform "A Multi-Media Experience" on August 8, 1973, in Centennial East. In one piece titled "Ruud Awakening," Schadd planned to "feature several alarm clocks placed around the recital hall, each set to ring at given times." *The Vidette*, August 3, 1973 (Vol. 86, No. 14, pg. 7).
- Two ISU students moved into the recently vacated presidential house, known as the University Residence. The newly married couple was tasked with maintaining the residence "and be responsible for its upkeep and security." Mr. John Betsche and his spouse deemed the offer "fantastic" and "quite a step up" from Hewett Hall, where Mrs. Betsche lived the year prior. *The Vidette*, September 5, 1973 (Vol. 86, No. 21, pg. 3).
- The year's first ISU Theatre Department production, *The Importance of Being Earnest* was announced. Planned for a two-week run, the show opened in the Westoff Theatre on October 11 and ran until October 20. *The Vidette*, October 10, 1973 (Vol. 86, No. 41, pg. 5).

25 years ago – Sept.-Oct. 1998

- The E-Mail Express opened on the first floor of the Bone Student Center. David Greenfield, director of Computer User Services, hoped to expand the program to multiple campus locations so the ISU community has multiple access points to the newly established email system. *The Daily Vidette*, September 11, 1998 (Vol. 111, No. 22, pg. 3).
- Though campus coffee choices were limited to dining halls, *The Daily Vidette* offered a list of local coffee house establishments within walking distance of the Quad. The Coffeehouse Deli on Beaufort (the only roasting house in Central Illinois), Life's Little Perks on Kingsley behind Atkin-Colby (open until midnight with live music), and Bagelman's on Main Street (fresh baked goods daily). *The Daily Vidette*, September 16, 1998 (Vol. 111, No. 25, pg. 3).
- ISU alum Albert Pizzamiglio, also known as Al Pierson, was honored on October 21 and recognized for his achievements in music. Then director of the Guy Lombardo Royal Canadi-

ans Big Band, Pierson attended ISNU and graduated in 1954 before becoming a music teacher. Pierson was a member of Glee Club, Blackfriars, and concert bands before forming his own band, the Al Pizzamiglio (Pierson) Band. *The Daily Vidette*, October 23, 1998 (Vol. 111, No. 51, pg. 3).

Half Century Club reunion to be held at Homecoming 2023

The annual program gives alumni an opportunity to catch up with classmates, make new acquaintances, participate in exclusive behind-the-scenes tours, and learn what's new at Illinois State. The events are not exclusive to graduates of the honored years. Any alumnus or friend of the University is invited to attend any or all of the Half Century Club activities. Office of Parking and Transportation changes for the 2023-24 academic year

- The Office of Parking and Transportation is implementing license plate recognition (LPR) to enforce permit requirements in the fall 2023 semester. Students will be limited to one license plate/vehicle to assign to their permit. Faculty and staff may enter more than one license plate/vehicle to assign to their permit.
- Most individuals will no longer be issued a physical permit. Instead, a virtual parking permission will be tied to your license plate. It is extremely important to correctly enter your license plate information and select that license plate during the purchase process. License plate entry requirements can be found on the parking website under the "parking" tab. View the information on LPR to find the requirements. You can edit an existing plate utilizing the portal ("pay citations/manage account"). If you need assistance, please contact our office. The following permits will still require a physical permit to be displayed: Reserved Space, Laboratory School, Departmental and Vendor Business, Guest, Board of Trustees, and Motorcycle.
- Permit effective dates are changing. Permits are now valid from August 1 to July 31 annually.

Illinois State University raises more than \$34 million during fiscal year 2023

Illinois State University raised more than \$34 million in private support during the 2023 fiscal year that ended on June 30, 2023. This is the second time Illinois State has raised more than \$30 million without an eight-figure gift commitment.

"The private support Illinois State University receives from do-

nors continues to be a point of pride for the University," said Interim President Aondover Tarhule. "Donor support allows the University to continue to grow and engage our students, faculty, and staff on campus. We are incredibly grateful for donors' continued dedication to strengthening Illinois State University."

Scholarship support is a key component of student success and retention. Donors established 76 new scholarships during fiscal year 2023, increasing Illinois State's endowed funds under management to 1,746. This fiscal year, a total of 3,350 scholarships were awarded to students.

One scholarship recipient impacted by the generosity of donors is fashion and merchandising major Ali Scace. Scace, originally from the St. Louis area, came to Illinois State to pursue her creative pas-

sion for clothing. With the help of scholarships, Scace was able to focus more on her studies.

"Scholarship support gave me the confidence I needed to tackle school. I cannot put into words how grateful I am for the scholarship support I received," said Scace. "I will never forget the generosity I was shown. It truly impacted my life in such a positive way."

fifth annual Birds Give Back in February. Redbird alumni, faculty, staff, students, and friends came together to raise \$1,031,225 from a record number of 4,439 individual gifts in just 24 hours on February 23.

During fiscal year 2023, the University also partnered with UNITE, a training, consulting, and technology company, to drive business engagement and increase collaboration. These strategic corporate partnerships and matching gifts also drove Illinois State University's fundraising success.

With careful management by the Illinois State University Foundation Board of Directors, the University's endowment grew during fiscal year 2023. The endowment is now valuated at more than \$204 million. Chair of the Illinois State University Foundation Board of Directors Eric Burwell '90 said the steady rise of the endowment is a continued strength of the University.

"The endowment is a source of strength for the University and allows donors' contributions to sustain the University's needs," Burwell said. "These resources enable the University to flourish and thrive now and for future generations of Redbirds."

"The continued growth in donor support showcases the impact and quality of education and experiences that our donors, alumni, and friends experience at Illinois State University," said University Advancement Vice President Pat Vickerman. "Illinois State's dedication to the development and success of the ISU family is reflected in the commitment donors make to ensure the University continues to advance and succeed."
