## **How Time Flies**

#### 150 years ago - 1871

• President Richard Edwards indicated in his report to the Board of Education that the year's class size was quite large for the time of year:

"The class admitted at the beginning of the present term is unusually large for this time of year, and contains an unusually large proportion of young men. Heretofore, since the breaking-out of the war, the ladies have constituted from three-fifths to two-thirds of the Normal Department. But in this class there are 63 gentlemen to 38 ladies. It will be seen that in the entire Department the sexes are just about equally divided."

#### 100 years ago – May–July 1921

- In cooperation with the American Federation of the Arts, the University arranged for an exhibition of 121 works of art from students at four national designs schools. Watercolor and black and white prints came from the Rhode Island School of Design, the Pennsylvania Museum School, the Boston Museum School, and the Prat Institute. The display would run from May 18 to May 28 and be available for viewing by the University community and the general public. *The Vidette*, May 19, 1921 (Vol. 33, No. 31, pages 1, 4).
- In celebration of graduation, the junior class treated the senior class to an outdoor picnic and parade on the Quad. After an early round of games, the senior class took part in an evening parade that included paper lanterns: "The procession of Seniors, headed by the Senior College graduates, moved with the accompaniment of music furnished by the orchestra over the campus in a winding trail. The lanterns they carried shone like glow-worms in the grass, and the effect of the light on the white dresses and black gowns and suits with the green background of trees and grass made an unusual illumination at twilight." *The Vidette*, June 13, 1921 (Vol. 33, No. 34, page 1).
- Titled "Sign of the Times," *The Vidette* reported on a small child's response to being one of the few houses in town to escape illnesses that were moving through town: "During the winter and spring just past, Normal was visited with an unusually heavy siege of child-hood diseases–scarlet fever, measles, whooping cough, etc. Nearly every house was decorated with the 'keep out' card. One little boy whose home escaped the placard was not to be left behind in having these badges of distinction. He had an idea and put it to work. That evening his father, coming home, saw a new sign on the front of the house—bearing the legend, 'Keep Out —Hiccoughs.'" *The Vidette*, July 12th, 1921 (Vol. 33, No. 38, page 1).

#### 75 years ago – May–July 1946

- W. A. Beyer officially announced his retirement after 37 years of service to Illinois State Normal University (ISNU). Beyer arrived at ISNU in 1909 from Bloomington High School during preparations for commencement exercises. Beyer recalled there were no caps and gowns during graduation and that only four buildings were on campus: Old Main, Industrial Arts (now Edwards Hall), North Hall, and Cook Hall. Originally divided into two departments–history and civics and economics and sociology–the entire unit combined into one department and named Dr. Beyer as its chair. When asked about his retirement plans, *The Vidette* noted, "He enjoys fishing and plans to do a lot of traveling and vacationing in the future." *The Vidette*, May 1, 1946 (Vol. 58, No. 22, page 2).
- *The Vidette* reported that the partial demolition and renovation of Old Main was underway. A fence surrounded the 85-year-old building, necessitating new foot traffic through neighboring buildings. The planned removal of the bell tower and top floor of the building would eventually stabilize the structure and make it safe for use. On the loss of the clock and bell, "Students will miss that historic landmark with its timepiece that so faithfully, and conveniently, told the hour when they had an eight o'clock class, or a few minutes before the next hour class began." *The Vidette*, May 15, 1946 (Vol. 58, No. 21, page 2).
- The ISNU Graduate School reported an enrollment of 101 students for the 1946 summer term. ISNU began offering graduate degrees on June 10, 1944, with an enrollment of just six students. The following June, three students received their Master of Education in science. *The Vidette*, July 10, 1946 (Vol. 58, No. 28, page 4).

#### 50 years ago - May-July 1971

- With no pay or academic credit, over 400 ISU students gave their time to local school children. In the ISU Tutorial Project, President Ed Rouleau felt the program was "one of the most worthwhile campus organizations." It provided ISU students opportunities to try out teaching early in their academic careers while providing educational support for local schoolchildren. At Coleen Hoose Elementary School and the Illinois Soldiers and Sailors School, principals reported positive results in their students who participated in the program. *The Vidette*, May 6, 1971 (Vol. 83, No. 65, page 1).
- Not to be confused with The Who, the Canadian rock band The Guess Who was scheduled to perform with opening act Smithsonian Institute at Horton Field House. Forming in 1964, The Guess Who gained attention when they performed for President Richard Nixon at the White House. Sponsored by the ISU Entertainment Board, the band "is acknowledge by critics as the first Canadian band to show that the northern country could produce a top rock aggregation." *The Vidette*, May 13th, 1971 (Vol. 83, No. 68, page 1).
- ISU graduate Randall J. Schaeffer was named the first director of the Bloomington-Normal Personal Assistance Telephone Help (PATH) Crisis Center. The Center's acting director, Dr. William Arnold, was appointed chair for the Department of

Speech Communications at ISU. *The Vidette*, July 22nd, 1971 (Vol. 84, No. 4, page 2).

#### 25 years ago – May–July 1996

- Student radio station WZND raised over \$1,000 for the ISU Child Care Center during its fifth-annual silent auction. Items donated from area businesses included a hotel getaway package, a mountain bike, free food, and a leaf blower. The ISU Child Care Center planned to use the funds to purchase educational computer software. *The Daily Vidette*, May 8, 1996 (Vol. 108, No. 159, page 3).
- Three ISU students were named recipients of the General Assembly Scholarships for the Illinois 44<sup>th</sup> Senate District: Ryan Koehl, senior, economics; Sara Marx, second bachelor's degree student, math education; Julie Thomas, sophomore, elementary education. Senator John Maitland listed "leadership and extra-curricular activities as well as academic achievements and grad point average" as factors for the three students winning the scholarship. *The Daily Vidette*, June 26, 1996 (Vol. 109, No. 2, page 3).
- It was announced at the June 12, 1996 ISU Board of Trustees meeting that the General Services Building would be renamed the Nelson Smith Building. Housing the ISU Police Department and other services, the name change would honor the University's longtime photographer and alum Nelson Smith. All four of Smith's daughters also attended ISU, as well as Smith's grandson, who was Reggie Redbird during his academic career. *The Daily Vidette*, July 17th, 1996 (Vol. 109, No. 5, page 3).

## The Constitution's pension clause

As someone who has listened to a number of candidates seeking election to the legislature for the first time, it is common to hear them indicate that the solution to "the pension crisis" is to amend the Constitution's pension clause. We had an election last November that resulted in several new members being elected to the Illinois legislature. Therefore, it is perhaps not surprising that we have had several new bills introduced this session that seek to do just that.

On February 24, the University of Illinois at Chicago chapter of SUAA sponsored a webinar on the pension clause, addressing whether SURS pensions are at risk. The two presenters were Ann Lousin and Eric Madiar. Lousin, a faculty member at John Marshall Law School, served as a research assistant at the 1970 Constitutional Convention. She provided a history of the adoption of the pension clause. She has written a book on the Illinois Constitution and is considered the premier authority about this topic. The other speaker was Eric Madiar, who served as the chief legal consultant for Sen. John Cullerton, president of the Illinois Senate, and who served as the Senate's Parliamentarian from 2011-2014. He wrote a very important article about the pension clause at the time that the legislature had proposed SB-1, a bill that would have significantly cut pension benefits. He has written several additional articles about the constitution since then. The most troublesome bill introduced this year is House Joint Resolution Constitutional Amendment No. 9 that would have multiple harmful effects on current pension provisions. First, it would limit the constitutional protection only to benefits that have already accrued, not to benefits that might be earned in the future. This would place the pension benefits of current employees at risk. This bill would also allow the legislature to reduce the pension benefits already earned, allowing the legislature to cut the pensions of those who have retired as well as reducing the benefits that have already been earned by current employees. The bill would also limit the ability of current employees or retirees from challenging any legislative actions to reduce pension benefits.

This bill faces several challenges before it could take effect. First, it would have to be approved in both the Illinois House and the Illinois Senate where the Democrats hold a supermajority of seats. Madiar considers this unlikely at the present time. But if that were to occur, it would then need to be approved by Illinois voters in the next general election, an action the last time such an amendment was sought in 2012. Even if that were to occur, it would then face challenges in federal courts as the contract clause in the U.S. Constitution prohibits states from unilaterally reducing contractual benefits such as those provided by the current pension clause of the Illinois Constitution.

The legal argument that likely would be used in Federal Court would invoke the police powers exception that exists to address an unforeseen emergency. A 2019 decision by the Rhode Island

Supreme Court that allowed the city of Cranston cut pension benefits for employees under such a police powers exception. This decision is being used by pension reformers in Illinois to argue that Illinois could use the same argument. Cranston faced this emergency because the Rhode Island legislature unexpectedly and significantly cut funding to the city, cuts that weren't foreseen or that the city had any control over.

The Supreme Court in Rhode Island approved a temporary cut to employee pensions. However, as noted by the Illinois Supreme Court in its 2015 decision when this argument was attempted in the SB-1 case, the pension issues in Illinois were easily predictable from the legislature's failure to fund the pension system. The pension crisis was in fact one of the legislature's own making. Secondly, while the Rhode Island decisions was only a temporary solution to a sudden problem, the Illinois case would seek a permanent solution to a long-standing, systemic problem. A 2020 decision by that same court rejected an attempt to make the pension cuts permanent.

Thus, Mediar's analysis is that an attempt to amend the pension clause of the Illinois Constitution would fail to obtain the necessary political support to be approved by the Illinois Legislature or by perhaps by the Illinois voters were it to be placed on the ballot. And even if it were to be approved by the voters, it would be unlikely to survive a challenge in the Federal Courts because of the contract clause of the U.S. Constitution. An attempt to argue the case using the police powers exception would likely fail. For now, an attempt to reduce your pensions by amending the Illinois Constitution is unlikely to be successful.

## Distinguished Professor Dr. Ali Riaz creates Graduate Student Award

The newly endowed Ali Riaz Graduate Student Award in the Department of Politics and Government will recognize the best student in Comparative Politics and International Relations. Distinguished Professor Dr. Ali Riaz was inspired to create the award after receiving the inaugural Thomas E. Eimermann Professorship in Politics and Government. The professorship was established by David Crumbaugh '73 to honor his former professor, who taught law-related courses for 38 years at Illinois State. Eimermann served as ISU's first pre-law advisor, founded and directed the mock trial program, and was chair of the Political Science Department from 1992 to 1998.

Riaz joined Illinois State University in 2002 and would later chair the Department of Politics and Government from 2007 to 2017. In 2018, he was appointed a Distinguished Professor. "I am humbled by the opportunities ISU and the department offered me

If you do decide to drop off a donation, the following are recommendations for summer and fall although any food or similar items will be welcomed: Summer: food-especially salad dressingand hot weather hygiene (razors, soap, deodorant); Fall: food-especially peanut butter-cans of chicken, and dental products.

## NEWS–SUAA Foundation scholarships and grants

The SUAA Foundation now offers up to six scholarships of up to \$1,000 per scholarship annually. The applicant must be **an SUAA member in good standing or the spouse/partner, child, or grandchild of an SUAA member in good standing**. In addition, the SUAA Foundation offers up to two grants of up to \$1,000 per grant annually for professional development activities (travel expenses are excluded). The applicant must be **an SUAA member in good standing who is currently employed at an Illinois institution of higher education**. The primary legislative goal for 2021 is protecting retirement security of all past, present, and future employees of Illinois' public universities, community colleges, and their survivors.

SUAA will review and evaluate all proposed initiatives and legislation relating to pensions, other retirement benefits, and the maintenance of a robust higher education system to determine their compatibility with the association's goals; and, as appropriate, will publicly support or oppose such initiatives and legislation either in part or in their entirety.

If legislation is enacted that SUAA considers to be in violation of the pension protection clause of the Illinois Constitution, SUAA is prepared to challenge that legislation in the courts in concert with coalition partners or independently if necessary.
