### **President's message**

This newsletter is sponsored by the ISU Credit Union. They have opened a new office on Airport Road in Bloomington. Stop by the new location, or visit the existing location at 1309 South Center Street in Normal to thank them for their support.

As this newsletter goes to press, citizens will be voting in the Illinois primary. Due to the last census, Illinois has undergone redistricting. The individuals on your primary ballot may not include the individual representing you in the Illinois legislature or the U. S. Congress, even if they are running for re-election. The redistricting also requires every member of both the Illinois House and Senate to run for re-election, either in their current district or they may decide to move to a new district if they believe their re-election chances will be better there. Remember that your current representatives in both the House and the Senate will continue to serve as your voice in the legislature until the new legislators take their seats in January 2013.

While a number of shell bills addressing pensions have been introduced, most contain little legislative language that suggests what will happen this spring. There are numerous options out there and many are described in the Legislative Report below. Many members of the legislature are under pressure from groups such as the Civic Committee and the Civic Federation as well as many editorial boards to finally address issues of the structural deficit in the state and the role that state pensions play in the budget deficit. These individuals would argue that we cannot (or perhaps will not) address these problems through tax policy, but must make painful cuts. Some of these groups seem especially interested in inflicting this pain on us no matter what the constitution says. Others are not so certain the legislature will take action to inflict pain in an election year and that legislative action this spring will be limited. Time will tell and it is important to remain vigilant.

Last spring we also witnessed the incredible mess created by the awarding of health insurance contracts in a way that disrupted continuity of care for many of our members. The health insurance contracts that were extended last year in response to the uproar these decisions made are expiring this June. The Commission on Government Forecasting and Accountability (COGFA) has authorized the Department of Health and Family Services to open bidding for new contracts. We all need to watch the outcome of the bidding process to ensure that the health care needs of our members are met by whatever the outcome is of this bidding process.

### Legislative report

At the time this newsletter went to press, the March primary was about to occur and it is unclear what challenges our pensions and benefits will face this legislative session. Unless there is an amendment to SB 512, the bill targeting pension benefits for current employees, it is unlikely to come to a vote, as there is little support for this bill in the legislature at this time. However, a number of shell bills have been introduced that could provide a vehicle for legislative action. A shell bill is one that has very limited provisions but can be amended as support for various positions becomes clearer as the legislative session progresses. Representative Biss introduced a shell bill on behalf of SUAA that would require the legislature to meet its annual obligation to fund SURS. There are others that are likely to provide alternatives to SB 512.

The governor supports shifting the costs of pensions to the universities, community college districts, and school districts. It is unclear whether this proposal will have much support as it would drive up the cost of tuition and provide pressure to increase local property taxes in a state that already ranks very high on property taxes. The proposal to shift the costs of teacher pensions to local school districts will likely face especially strong opposition in the legislature. The Civic Federation is pushing for support for provisions in SB 512, proposals to require retirees to pay 50 percent of the cost of their health insurance and, not surprisingly given actions taken in other states, limiting the size of the COLA and eliminating the compounding of the COLA increase. The Civic Committee has also begun establishing a PAC that they expect to be extremely well funded to recruit and support the election of candidates that will challenge existing members of the legislature that have not supported these measures.

While not yet included in a bill, the Institute of Government and Public Affairs (IGPA) at the University of Illinois has perhaps the most interesting proposal that has come forward thus far. It has many good features but it also would target pension benefits for current employees. It is described in more detail in the following section.

Many legislators are engaged in private discussions that they are not as yet willing to make public. Very little of this has been drafted into legislative language, but we shouldn't be surprised to see at least some of this move forward during the remainder of this legislative session.

On a different note, HB 5531 threatens the tuition waiver benefit for the children of university employees while the legislative tuition waivers go unaddressed. This bill was passed by the House Executive Committee on February 29 with on a 9-2 vote. Representatives Dan Brady and Mike Bost were the two dissenting votes. While we should express concern on behalf of our university colleagues that have been working with the expectation that their children would receive this benefit, we should also recognize that this is yet another factor that makes it more difficult to attract and retain outstanding employees to the University.

### **IGPA** pension reform proposal

The Institute of Government and Public Affairs (IGPA) at the University of Illinois has drafted a pension reform proposal that has both good and bad features for our members. The report is likely to have influence in the legislature as Tom Cross, minority leader in the House and the primary supporter of SB 512, and Lawrence Msall, former president of the Civic Committee, the group pushing SB 512, are members of the institute.

The good news is for individuals hired after January 2011. These individuals receive a substantially reduced pension under the tier II arrangements and are not vested in SURS until they have been employed for 10 years. If someone in this group were to be denied tenure or to leave after nine years and 11 months, they would not receive any pension benefit nor would they have earned any social security credits. Such a lengthy vesting period is extremely unfair and not in line with other employers.

IGPA proposes a vesting period that is phased in, beginning with two years of service.

IGPA also proposes a hybrid pension plan to replace the new tier II plan. They suggest that the state provide 1.5 percent of salary for each year of service as a defined benefit plan. This would then be supplemented by modest state contributions to a modified defined contribution plan. The total state contribution would equal approximately 6.2 percent, the amount employers are required to



pay into social security. Universities would then add a contribution equal to 50 percent of employee contributions or about 4 percent under current SURS provisions. University contributions would be phased in over time. This would likely be a significant improvement over the existing tier II plan, would be mandatory for new employees, and would be the only plan available to them. Current employees could choose to move to this plan and participants in tier II would likely do so.

The bad news is for employees and for retirees. IGPA proposes that the Effective Rate of Return be reduced for the money purchase formula to a benchmark approximately equal to the Treasury Bond Index. This would be a substantial reduction and would be expected to reduce benefits under money purchase substantially, making the benefits provided under the money purchase formula approximately the same as the benefits provided under the years of service formula. Currently, about 66 percent of SURS participants retire under money purchase and about 34 percent retire under the years of service formula. This would make the money purchase formula of little use except for individuals with a number of years of service and nearing retirement. The reason for this is that the Effective Rate of Return historically has exceeded the actual returns achieved by SURS by a fraction of a percent. However, even a small percentage can result in substantial sums when multiplied by the number of participants that are active in SURS. This means the state was providing an added subsidy to those that retired under this formula. However, the reduction would probably yield a return of 2-4 percent, much less than SURS has historically earned on its investments. Either this would mean that SURS would have little incentive to exceed the bond index or a substantial portion of SURS earnings would revert to paying off the pension debt. While adjustments to ensure the Effective Rate of Return did not exceed the actual earnings that SURS achieved is appropriate, such a drastic reduction is questionable.

Secondly, while cognizant of the Arizona Court decision cited on page 4, they propose charging current employees up to 3 percent more to fund their pension. They recognize the constitutional issues that this would invoke. Thus, combined with the change for the money purchase formula, this would result in current employees paying more for what many would experience as substantially reduced benefits.

For retirees, the hybrid system would mean less employee contributions would be coming in to pay current pensions and the state would not be able to take a pension holiday on their contributions to the defined contribution portion of the hybrid plan. This could create even greater concerns down the road regarding the ability of SURS to pay future pension benefits.

### **Court decisions**

Several recent court decisions may have a bearing on efforts to reform pensions in Illinois. Most notable is the decision in Arizona. The Arizona Constitution includes a non-impairment clause similar to that in the Illinois Constitution. A district court judge in Arizona ruled that requiring employees to pay an additional 3 percent of salary without an offsetting benefit violated the contract that the non-impairment clause in the constitution established.

Somewhat different reasoning was applied in the case of New Hampshire when the state raised employee pension contributions by 2–2.5 percent. New Hampshire's constitution does not specifically protect pensions but does include a provision that the state cannot impair contracts. A superior court judge ruled against the state because the state had impaired a contract established when those employees began employment with the state.

In a third case in Florida, a state judge struck down a provision requiring employees to pay an additional 3 percent toward their pensions and also struck down provisions that would reduce their cost of living increases. The judge noted that a budget crisis does not mean the state of Florida can set aside its constitutional obligations.

None of these court decisions extend beyond the state borders, but should nevertheless reduce enthusiasm for efforts to increase pension costs for current employees. These decisions are good news for our members.

### How time flies

#### 150 Years Ago • 1862

- Perkins Bas is still acting principal though Richard Edwards and becomes ISNU's second president in 1862.
- Leander Potter who left to fight in the Civil War, is scheduled to return to the faculty.
- There are 285 students enrolled in both the University and the model school.

#### 100 Years Ago • February 1912

• The annual Founders Day banquet is held on February 17. Guests are invited to dine at the Manual Arts Building and listen to farewell speeches for the departing vice president, Henry McCormick. Many ISNU notables attended including fourth President John Cook and Professor June Rose Colby. Former Professor Charles DeGarmo sent a letter to be read at the banquet. Party goers were reportedly out until 2 a.m. the following morning.

#### 75 Years Ago • January/February 1937

- The Blackfriars group held its annual pledge ceremony. The Vidette article reads: "Instead of 'Swing Mr. Charlie' it was 'Swing Mr. Paddle' last night on the Blackfriar pledges. What hurt the most was that the pledges furnished the paddles so there would be no expense to members if one happened to break."
- The annual Founders Day banquet is held in Fell Hall. J.W. Carrington, head of the Placement Bureau, was the toastmaster while Thomas Berger '12 gave the address of welcome. Participants at this dinner spoke of organizing an Alumni Council to be located in McLean County.

#### 50 Years Ago • January/February 1962

- ISNU officially starts doctorate work. Departments offering doctorates are art, biological sciences, and education.
- The library offers open stacks to students rather than students requesting staff to pull their materials from the shelves. Many on campus are happy with this change while others believe it will be too confusing.
- A birthday party for the University is held on February 20 in lieu of a Founders Day celebration. The theme for the evening event was "Teaching in a World Community," and a panel made up of graduates and undergraduates spoke on the topic.

#### 25 Years Ago • January/February 1987

 ISU is in its second semester of offering students access to computers in microcomputer labs. However, the University needs to pay for these machines, so students are charged a \$30 English materials fee.

### Exchange email/calendar users
