## **ISUAA** election results/annual meeting summary

The ISUAA annual meeting was held at the Clarion Hotel on June 7, 2006. Christ Schwelle was elected president; Carolyn Bartlett, secretary; and David Doss, Janet Kuhns and Tom Shilgalis, directors. Continuing their positions on the ISUAA board are Sharon Quiram, vice president; Paul Schertz, treasurer; and Jude Boyer, director.

Distinguished service awards were presented to Gene Irving, Don Kachur, and Mary Shadowens. Irving is a past president of ISUAA and played a leading role in the establishment of the survivors advocacy program. Don Kachur served ISUAA as membership chair and led the chapter's explosive growth in membership. Shadowens, as benefits supervisor in Human Resources, was of tremendous assistance to those planning their retirement and also helped establish the survivors advocacy program.

Treasurer Paul Schertz reported that ISUAA will finish 2005–2006 with slightly more income than expenses and a positive cash balance. Payroll deduction for payment of dues will now be available to pre-retirees employed by Illinois State.

Schwelle reported that as of May 31, 2006, ISUAA membership totaled 1,351. The participation rate of 63 percent is the highest among comparable universities. Total SUAA membership as of May 31, 2006, was 14,284.

## **Issues potentially affecting SURS annuitants**

This is a good time to summarize the issues facing state university retirees, pre-retirees, and survivors. Not much will likely happen until after the November elections and the General Assembly convenes in January. In the meantime, SUAA and others in the higher education coalition are gearing up to advocate for members. Tom's perspective comes from his years as SUAA's legislative chair and his continuing research and analysis of legislative issues. Christ is a relative newcomer, but as a member of the board of directors of SUAA's political involvement committee (SUAACTION), he has been involved in discussions of these topics. The following represents our collective view.

#### Inadequate funding of state pensions (including SURS)

In the FY06 and FY07 budgets, the state swept over \$2 billion from the state pensions system to use for other purposes. This gave Illinois the dubious ranking of No. 1 as far as the worst-funded state pension system. Little can

Published quarterly Illinois State University Annuitants Association Campus Box 1300 Normal, IL 61790-1300 be done to *make* the state restore proper funding to the pension system. What *can* be done is reminding elected officials and the public that payment of these pension benefits is a legal obligation that is not going away. The pensions, including the 3 percent compounded annual increment, are protected by state law. Annuitants earned them and had their share deducted from their pay. The pensions are not the problem. The problem is that the state chose to divert money away from these obligations for other purposes.

### Constitutional convention (ConCon)

Several interest groups in Illinois are looking to use a ConCon to diminish pension rights for public employees. (Tom Wilson explained the ConCon process is detail in the May issue of *ISUAA News.*) The general public is not sympathetic to those with public pensions.

Since a ConCon could open up a real "can of worms" for all kinds of issues, it may very well not happen. If Con-Con does happen and if the constitutional provision that prevents state pensions from being diminished/impaired (reduced) is eliminated, possible legal action would include the argument that the state cannot just cancel out benefits earned under properly enacted legislation somewhat like the principal of "ex post facto" in criminal law. The diminishment/impairment provision is not just a policy or regulation. It helps that annuitants paid their share to help fund the system and annual increments. Voters in Illinois will decide in 2008 whether or not to have a ConCon.

#### Pension reform

Among pension reforms so far: the elimination of the money purchase formula for new employees; the transfer of annual interest rate determination from the SURS board to the State Comptroller; and the transfer, from the state to employers, the pension costs of salary increases exceeding 6 percent in the final four years before retirement. Some of these 6 percent provisions have since been modified. A number of other changes were considered and could be reconsidered.

#### Health insurance benefit reductions

All state retirees are vulnerable. There is no protecting law. The existing pattern, which is expected to continue, is that AFSCME will be negotiating health insurance benefits with Central Management Services and everyone affected will live with the results. AFSCME has a good track record and seems to be committed to protecting retirees. One likely problem is that a new accounting standard (GASB 45) will take effect to acknowledge future health insurance obligations. This will clearly show the state's obligation and will attract the attention of government officials and the public.

#### Exemptions of pensions from state income tax

In Illinois, both public and private pension income and Social Security benefits are exempt from state income tax. As mentioned earlier, Illinois has a revenue problem. Previous discussion, which focused on raising additional revenue for K-12 education, included taxing pension income. Nothing came out of these discussions, but this could come up again. Legislators will be reminded that (most) SURS annuitants do not receive Social Security benefits and those who do receive reduced benefits. A likely stance is that if pensions are taxed, a certain amount of pension income should be exempt to protect those with low or modest income. Only pension income above that amount should be subject to tax.

#### Social Security offsets

These offsets financially penalize those eligible for SURS benefits and Social Security benefits. This is especially unfair to those receiving only a small SURS pension. SUAA and others representing public employees are currently educating congressional staff regarding the unfair situations created by these penalties with specific situations being cited. A number of knowledgeable people believe it is important to gather information and continue educating, but, given the federal budget problems and cost to correct things, this issue will not get greater attention until there is more serious discussion on Social Security reform.

SUAA will continue to keep a close watch on these and other issues that could impact members and utilize its statewide structure to advocate on behalf of members. By being a member you help provide the numbers that give SUAA some clout. If you're not a member, isn't it worth a couple of dollars a month to join?

## ISUAA annual meeting summary

Seven delegates from ISUAA attended the State Universities Annuitants Association (SUAA) annual meeting in Springfield, June 14–15, 2006. Delegates from chapters throughout the state attended. Most of the conference was devoted to identifying and clarifying issues that could impact annuitants, and discussing strategies for dealing with these issues. Among the speakers were representatives from AFSCME and the Service Employees International Union. These unions and SUAA are part of a coalition of organizations working together on issues of common interest, such as state pensions. Dan Slack, the new executive director of SURS, also addressed SUAA. One session was devoted to survivor assistance. Representatives from SURS discussed issues survivors need to address, and ISUAA's Mary Liverman and Edna Johnston presented information about ISUAA's survivor advocacy program. Mary and Edna were very effective in motivating other chapters to consider establishing similar programs.

The issues discussed by SUAA are familiar. These include inadequate state funding of SURS; pension "reform"; potential health insurance benefit reductions;

For more information or to receive a brochure call (309) 438-2160. the possibility of losing the state income tax exemption for pensions; and the potential of a state constitutional convention with possible retraction of the constitutional provision that prevents state pensions from being diminished. SUAA's legislative committee continues to analyze these issues and develop strategies. SUAACTION (a political involvement committee) is gearing up to have these issues addressed by members at the local level with local legislators. On the federal side of the ledger the Social Security offsets, which penalize those receiving both SURS and Social Security benefits, continue to receive attention.

Once again ISUAA was the recipient of awards. ISUAA has 1,351 members, a 7 percent increase over last year. ISUAA's 63 percent participation rate is the highest among residential university chapters. SUAA's membership total of 14,300 is a significant increase over last year's 12,800 and likely demonstrates the increasing realization by SURS participants that having a group like SUAA advocating on their behalf is a good idea. In addition to the membership awards, ISUAA's Tom Wilson was recognized for his service on SUAA's legislative committee.
