Those of us who earned Social Security benefits are dismayed that these are reduced because we also earned SURS pensions—even partial pensions. I hope non-members will consider joining to add to our membership numbers and influence. Certainly it is worth a couple of dollars per month to help protect what you worked so hard to earn. If you want to actively participate in ISUAA activities we'd love to have you do so, but if all you want to do is support our work by being a member, that's okay, too.

I want to take this opportunity to thank some people who have been actively involved in ISUAA. Sharon Quiram is leaving as vice president of our chapter after four years in that position. ISUAA election results/ annual meeting summary

The ISUAA annual meeting and dinner was held in the Old Main Room at Bone Student Center on June 20, 2007. Richard Dammers was elected vice president; Sue Nolan Killian was elected treasurer; and Jude Boyer and David Doss were re-elected as directors. Continuing in their positions on the ISUAA board are Christ Schwelle, president; Carolyn Bartlett, secretary; and directors Janet Kuhns and Tom Shilgalis.

The Distinguished Service Award was presented to outgoing treasurer Paul Schertz, who served in that capacity for six years—the maximum allowed. Among Schertz's achievements was leading the initiative to establish payroll deductions for ISUAA dues payments from current university employees.

Committee and task team members were acknowledged for their service and Schwelle provided a summary of the work of the board during 2006–2007.

ISUAA year in review: 2006–2007

- ISUAA membership is currently 1,372, approximately the same as a year ago. SUAA membership is 15,140, compared to 14,262 last year. Payroll deduction for dues payments by those still employed by Illinois State was implemented this year.
- University personnel assistance for ISUAA began a transition from Human Resources to University Advancement/Foundation during the year. Barbara Todd, executive director of internal campaigns, is the designated university liaison to ISUAA.
- University-related financial support, including newsletter sponsorship, grew from 30 percent of the chapter budget to 35 percent. This allows dues to remain very affordable while keeping ISUAA in the black financially.
- ISUAA published four newsletters to keep members informed about issues affecting them. University Marketing and Communications (UMC) is now doing the newsletter layout. The annual chapter directory continued to be published, currently with the assistance of University Advancement and UMC. ISUAA continues to maintain a Web site (www.annuitants.ilstu.edu). Added this year was a legislative section.
- Human Resources had to cease providing information on retiree deaths/survivors to the ISUAA Survivor Advocacy Team in late fall. This action was necessitated by recent ethics legislation. An interim plan for obtaining information is in effect and a new plan is being developed. ISUAA worked with University Advancement to include survivors on the invitation list for semiannual retirees' breakfasts.
- ISUAA had an annual dinner meeting plus three luncheons. The 35th anniversary of ISUAA was celebrated at the

- December holiday luncheon. At each of these events canned goods and other items were collected for local charities.
- ISUAA was represented at all three SUAA statewide meetings. The past president of ISUAA, Jan Cook, is on the SUAA executive board and the current chapter president is treasurer of SUAA's political involvement committee, SUAACTION. ISUAA members voluntarily donated over \$11,000 to SUAACTION in 2006–2007.
- ISUAA's legislative/political group continued to maintain a
 positive relationship with local legislators. A Social Security
 penalties interest group was formed this year.
- ISUAA members continue to be the nucleus of the University Club, which holds weekly discussion hours and two gourmet dinners each semester. ISUAA also coordinated activities in golf and pool for its members.
- Projects in the works include formalizing the relationship between ISUAA and the Illinois State University Foundation, organizing ISUAA archives, clarifying and possibly expanding Illinois State University survivor privileges, and exploring an intergenerational learning initiative.

A/P staff brown bag session

On April 18, the Administrative/Professional Staff Council sponsored a brown bag session, "What's Happening with Your Retirement Benefits?" The panelists were Bone Student Center's Jim Carlson, chair of the SURS Member Advisory Committee and ISUAA President Christ Schwelle. There was an overflow turnout of current university employees concerned about what lies ahead as they approach retirement.

Intergenerational leadership forum

On April 23 ISUAA members Janet Bremner and Christ Schwelle represented Illinois State University at the Illinois Senate Forum on Intergenerational Leadership. College students and retirees from across the state convened in the Illinois Senate Chamber for this meeting led by Senate President Emil Jones Jr. One of the examples cited as a successful initiative for bringing generations together, with positive results, was Illinois State's Senior Professionals program, in which retired professionals mentor college students.

Are your retirement benefits secure?

This issue of the newsletter is a good time to assess the security of our retirement benefits. Despite the underfunding of pensions, the negative attitude (perhaps hostility in some cases) of citizens toward public pensions, and trends in the private sector, your pensions are relatively safe. This is true for those still working in "the system" as well as retirees. The State has an enforceable contractual obligation to pay pensions, including the 3 percent annual increment.

That said, leaders in the business community believe that pensions for public employees are too generous and the State should not be locked into not being able to diminish pensions. Such thinkers may attempt to use a State constitutional convention (con-con) to eliminate or modify the state's constitutional obligation. Other interest groups will not want a con-con because it could open up a real can of worms on a variety of issues. If a con-con did occur and the State did attempt to eliminate or modify its pension obligation, legal action could be brought against the State on the grounds that benefits earned under properly enacted legislation cannot be cancelled out. It is like the *ex post facto* principle in criminal law. It helps that we paid our share to help fund the system and the annual increments. The role of SUAA and others advocating for retired public employees is to closely monitor the situation and take the steps necessary to maintain the State's obligation. Health insurance benefits are an area where we are more vulnerable. There is no protecting constitutional provision. The existing pattern, which is expected to continue, is that the American Federation of State, County, and Municipal Employees (AFSCME) will be negotiating health insurance benefits with the State and everyone affected will live with the results. AFSCME has a good track record and seems to be committed to protecting retirees.

Other continuing issues of concern include eliminating or modifying Social Security offset penalties and the potential for taxing State pensions.

SUAA annual meeting summary

Delegates from ISUAA attended the State Universities Annuitants Association (SUAA) annual meeting in Springfield on June 13 and 14. Chapters from throughout the state were represented. Among the speakers were Dan Slack, executive director of SURS; State Representatives Rich Brauer and Robert Prichard; Jim Reed of the Illinois Education Association (IEA); and J. Thomas Johnson, president of the Taxpayer's Federation of Illinois. Brauer is a member of two pension-related committees and Prichard is a member of two higher education committees. Reed is IEA's director of government relations. Johnson's interest lies in monitoring the state's fiscal situation and assessing implications for possible changes in the state's tax structure. No one would hazard a guess on what the state budget or tax structure would look like. It was mentioned that interest groups would be looking to advocate for a state constitutional convention. This was the first annual meeting for new SUAA executive director Linda Brookhart.

The issues discussed by SUAA are familiar—inadequate state funding of SURS, health insurance benefits, the possibility of changes in the state's tax structure, and the potential of a state constitutional convention with possible retraction of the constitutional provision that prevents state pensions from being diminished. SUAA's legislative committee continues to analyze these issues and develop strategies. On the federal side of the ledger the Social Security offsets which penalize those receiving both SURS and Social Security benefits continue to receive attention. SUAA's political involvement committee, SUAACTION, continues to evolve. The voluntary fundraising campaign raised about \$127,000 in 2006-2007 to use for political activity. ISUAA was responsible for \$11,385 (9 percent) of the total amount. The amount generated will help SUAACTION improve our visibility and influence politically. SUAA continues to grow with membership now exceeding 15,000. ISUAA, with 1,372 members, represents 9 percent of the SUAA total.

SUAA decided not to pursue a dues increase at this time. The situation will be assessed again next year.
