President's message

No doubt the state budget crisis will continue to dominate our time this next year and the issues that arise from this crisis will continue to occupy significant portions of our time. During the past year, we have faced the sudden imposition of a dental premium through the unilateral action of the governor and a proposal to enact a health insurance premium for annuitants of as much as \$500 per month for annuitants who are not eligible for Medicare and who elect coverage under the Quality Care option. Fortunately, the effort to impose these premiums appears to be dead for the time being. However, state funding of the pension systems appears to be a continuing concern at the present time, and as of this writing, unless the legislature can agree to a funding package, SURS may face the risk of needing to liquidate some assets in order to pay current pension obligations.

Significant challenges lie ahead and we need your help and support, and the support of your friends and colleagues. If you know someone is a participant in SURS, whether they are a current employee or an annuitant, and they are not yet a member of ISUAA, encourage them to join. And remember to pay your annual dues, or even better, sign up for payroll deduction or to have your dues automatically deducted from your monthly SURS pension. That ensures that you will not set this notice aside and then forget about making your dues payment. And if you want to help in other significant ways, let a member of the board know of your interest. We often need help on various projects and each year face the task of identifying new members for positions on the board, committees, and task forces.

Christ Schwelle has stepped down as president after serving two two-year terms in this capacity. Under his leadership, ISUAA has grown and prospered. It was most fitting that Schwelle was recognized with a Distinguished Service Award at the Annual Dinner. I am pleased that he has offered to provide advice and counsel to me as I step into this role and that he will continue to serve the association as a newly elected director.

I also want to offer my congratulations to Jan Cook, also a recipient of a Distinguished Service Award. I am pleased to offer my appreciation for all the work outgoing members of the board have provided and to express my best wishes for the future. Thanks to Carolyn Bartlett for her work as secretary and to Janet Kuhns as a director.

I hope to see you at the Fall Luncheon on September 1. President Al Bowman will be our guest speaker. He is both a member of ISUAA and a great supporter of our association. Future events of interest to our members are listed in this newsletter. Please take advantage of these opportunities to socialize, learn, and enjoy superb entertainment.

50 Years Ago | July-September 1960

- July—The Teachers College Board approved an operating budget of \$6 million for ISNU for the 1960–1961 fiscal year.
- September—A Student Health Insurance plan was put into place for all full-time students.

25 Years Ago | July-September 1985

- July—The North Central Association of Colleges and Schools announced the continued accreditation of Illinois State for 10 years.
- ISU's Metcalf Project to enhance reading comprehension and writing skills among elementary school children was one of 17 model teacher preparation programs recognized by the AASCU for its excellence in integrating research findings with instruction.
- August—Fifty-eight faculty members won 90 grant awards worth more than \$3 million (in fiscal year 1984 to 1985), a record amount and a 42 percent increase over the previous fiscal year.
- September—Fall enrollment reached a record of 20,419 students. The Student Health Service received accreditation from the Association for Ambulatory Health Care.
- The Board of Regents requested \$86.3 million for Illinois State for fiscal year 1987.

- August—David Strand began his term as interim president
- August—International House celebrated its 25th anniversary
- September—The Board of Regents approved a fiscal year 1997 operating budget request of \$118.6 million for Illinois State.

Annuitants Association election results and annual meeting summary

The Illinois State University Annuitants Association annual meeting and dinner was held on June 2 in the Old Main Room of Bone Student Center. Larry Alferink was elected president, Sharon Quiram was elected vice president, and Peggy Hundley was elected as secretary. Christ Schwelle was elected to a position as a director and Martha Burk was re-elected to this position. Continuing in their positions on the board are Sue Killian, treasurer, and Jude Boyer and David Doss, directors.

Jan Cook and Christ Schwelle were recognized as recipients of the Distinguished Service Award. Cook has served on the ISUAA Board of Directors, as president, as a member of the SUAA Membership Committee, and as treasurer of the SUAA Board. She has coordinated the Helping Hamper program and helped to initiate a survey on Civic Engagement of our members that will prove helpful as we talk to legislators. In an effort to keep local dues as low as possible, Schwelle sought and obtained sponsors for the newsletter. He also served as a SUAA Foundation director in addition to his work advancing the association during his two terms as president.

Schwelle provided a brief summary of the health insurance issue and thanked all of those who took the time to contact members of the legislature opposing the imposition of premiums. He noted that this issue appears to be dead, at least for the time being.

Helping Hamper

The Helping Hamper for our September luncheon will be for the Crisis Nursery at the Children's Foundation in Bloomington, which cares for youngsters during family emergencies like fires, auto accidents, or the illness of a caregiver. Their babies, toddlers, and primary age clients can use healthy foods and snacks like cereal, applesauce, fruit juices, and Jello. The staff appreciate receiving low sugar foods, since many of the children are under stress and get more keyed up when they eat a lot of sugar.

The kids also enjoy brightly patterned paper plates, cups, and napkins, of any theme. Football? Graduation? Great!

And if you know someone who has outgrown the diapers part way through a package, do grab the leftovers. Sometime in any week, there will be a client who wears that size.

Our June collection for the St. Vincent de Paul Food Pantry at Main and Locust garnered a bounty of fruit, cereal, pasta, and canned goods, as well as enough deodorant, soap bars, and disposable razors to fill the pantry's shopping cart to the top. "It is great that you folks think of that. It makes a difference to people to feel clean in hot weather."

We continue to collect Box Tops for education for the PTO at Thomas Metcalf School. These are the small rectangles, up to postage stamp size, found on packages of General Mills, Kleenex, Cottonelle, Betty Crocker, ZipLoc, and other brands. They can be redeemed for 10 cents each to support special projects and equipment for schools. A collection basket is on the table with the nametags at the entrance to our luncheon. Thanks!

Legislative updates

Representative Dan Brady was an invited guest at the May Board Meeting. He was invited to provide his perspective on issues facing the legislature and to listen to board concerns on issues facing annuitants. Discussion primarily focused around potential outcomes of budget negotiations, payments into the pension systems, and the possible imposition of Health Insurance Premiums by The Emergency Budget Act proposed by the governor. Brady indicated that as The Emergency Budget Act was currently written, the governor would not have to power to impose the cost of health insurance premiums on annuitants. He also indicated that unless an agreement can be reached on borrowing, payments to the pensions systems would be a problem.

Larry Alferink and Christ Schwelle also attended a fundraiser for Senator Dan Rutherford, Republican Candidate for State Treasurer with funding provided by SUAAction. As a member of the legislature, Rutherford has opposed changes to the pensions of current employees and annuitants, and we attended to provide a voice on issues of importance to our members.
