She was appointed Secretary for the first meeting, appointed to the committee to draft by-laws for the chapter and was a Founder and Charter Member of ISUAA, secretary-treasurer for two terms, Chapter Secretary of three additional terms, Chapter Representative to AASURSI/SAA and Editor of the first Chapter "Yearbook" now called the "Directory".

Oressea in cooperation with Ethel Stein, wrote the "Introduction to the History of the Illinois State University Association" based on 20 years of minutes and other chapter records-1971-1991

ISUAA Honors Ruth Barber

Ruth Barber, wife of the late G. Bradford Barber, has been presented with an honorary life membership in both the Illinois State University Annuitants Association (ISUAA) and the State Universities Annuitants Association (SUAA). LEGISLATIVE REPORT Tom Wilson, Legislative Co-chair

Things have been quiet in Springfield over the past three months. Most of the decision makers are in Chicago, making mostly bad decisions. Behind the scenes it appears the Governor will ask for what is called euphemistically a "pension holiday". The State will not make its "required" payment into the pension systems for fiscal year 2005 beginning on July 1, 2004.

This is a very serious problem, although it should be more of a concern for actives and recent retirees than it is for those of us who have been retired for 10 or more years. SURS has over \$11 billion in assets. Even if there is no return on those assets, the assets could be spent down until all that's left is the toilet paper in the SURS building. Assuming the contribution level for employees remains at 8% that will generate additional income for SURS. Thus, unless our life spans greatly

exceed expectations, there will be money available to pay our pensions. But eventually the money will run out and will not be enough to begin to cover pensions 25 or 30 years from now.

The bankruptcy of SURS and the other State of Illinois retirement systems is quite a few years in the future, but it's going to happen if the State doesn't begin to pay off its liability to the pension systems. The only alternative would be for the State to take a huge portion of the State's operating budget to pay pension costs. Instead of the current 4%, pension costs would have to be 30% of the budget.

This is being written on January 14, and I hope I am wrong about what the State plans to do. It's not a happy outlook, but Happy New Year anyway.

2003 LEGISLATIVE ISSUES Daniel P. Brady State Representative, 88th District

There were a few legislative changes during the 2003 Session in Springfield regarding pension payouts and the funding of pensions.

There was a legislative change to the State Universities Retirement Systems (SURS). House Bill 3183 changed and clarified different provisions of this legislation. One of the changes is the way a benefit to an alternate payee of a participant in the SURS Self-Managed Plan may be expressed as a flat-dollar amount or a percentage of the participant's account. HB 3183 also allows SURS to pay benefits regardless of whether a guardian has been

appointed. The remaining changes were technical.

Other than HB 3183, the Illinois House of Representatives did not approve any pension legislation, per se during the last session. In the past, major pension legislation required the approval of the Pension Laws Commission. The House Democrats failed to appoint members to the Pension Laws Commission. Since members were not appointed to the Commission, there were not enough members to meet to approve legislation. Without Commission approval the Senate refused to deal with many of the more significant pension proposals.

The Governor also proposed merging SURS with TRS. This proposal was met with significant opposition and was never introduced into legislation. Your association and I will monitor this and other possible proposals closely in the new session.

As of November 21, 2003, the family campaign had 797 donors pledging a total of \$4,882,414.91. That's a very grand total, but we're not done yet! Redefining "normal": The Campaign for Illinois State University will end December 31, 2004. That gives us just 300 or so days to do the very best we can, and I think we can do better.

Susan Kern, longtime faculty/staff member, and currently Vice President of University Advancement, along with Interim President Al Bowman, also a longtime faculty/staffer are challenging us to have 1000 donors to the family campaign by year-end.

It's a big goal, but I think we're up to it. So many of you called after last fall's article in this newsletter, and some very nice gifts are in the works. Others have stepped forward with wonderful one-time gifts to favorite projects: seats in the new Performing Arts Center, contributions to the Arena completion project, dollars for departmental activities including travel money for students to attend conferences.

Why give to the family campaign piece of Redefining "normal?" Because the dollars extend the legacy you have already left. First, annuitants' gifts represent both the good work of the past and faith in the future. Second, your gifts truly make a difference, and soon

2004 SUAA LEGISLATIVE GOALS

The State Universities Annuitants Association (SUAA), a voluntary organization of about 11,000 members, supports benefit maintenance and improvements for members of the State Universities Retirement System of Illinois (SURS).

Retiree and Survivor Benefits

Death Benefit – Increase the SURS death benefit from \$1,000 to \$5,000. The benefit has been at \$1,000 since 1959. SURS has indicated that the cost of this benefit is negligible.

Inflation Adjustment – Provide an ad hoc increase for those who retired before 1980 (or for the survivor). Inflation in the 1970s averaged about 10% per year, and retirees from that era have never come close to achieving a cost of living increase.

Health Insurance

State Group Health Insurance – Maintain current health benefits for State university retirees, survivors, and employees.

CCHIP Dependent Premium Assistance -

Reduce the dependent's payment for the Community College Health Insurance Program (CCHIP). At present dependents under age 65 pay about \$6,500 per year for health insurance and those 65+ without Medicare pay over \$10,000 per year.

Medicare Premium – Provide State payment of the Medicare Part B premium for State retirees with Medicare. The State's health insurance payment is reduced by about 60% for State retirees who are Medicare recipients. Work out a fair plan for employer payment of Medicare B for community college retirees.

Funding and Control of SURS

State Required Contribution - Support actuarially certified funding for SURS and the other State retirement systems for fiscal year 2005, which begins July 1, 2004.

Service and Investments – Support the autonomy of SURS to serve all its members and to make investments in the best interest of those members.

Federal Government Legislation

Social Security Offsets – Remove the socalled "Windfall Elimination" provision and the Government Pension Offset which greatly reduce earned Social Security benefits for many SURS retirees and for teachers retired from public schools in Illinois.

Deduction for Long-Term Care Insurance Premiums – Amend the Internal Revenue Code to allow the full deductibility of insurance premiums paid for long-term care. Currently, only a portion of the premium is deductible and then only if approved medical expenses exceed 7.5% of income. Guarantee that if IRS rules are followed, benefits (if needed) would not be subject to any federal income tax.
