The annual budget is funded through yearly green fees, cart rentals, merchandise and food/beverage sales. Capital improvements are funded through Student Fees and private donations.

#### SOCIAL SECURITY VS SURS

Mr. Bill Carter of Bloomington's Social Security Office was on campus several times this winter to discuss questions about what SURS folks need to know about Social Security before they turn 65. He addressed the key factors affecting the Windfall provisions that limit Social Security payments to people collecting a government pension, and the Social Security Offset on benefits to surviving spouses, then answered a great many individual questions. At each session I noted that several people would ask the same question and get quite different answers because their circumstances were different.

We are inviting him back next winter, when a different group of people will be approaching age 65.

#### LEGISLATIVE REPORT Tom Wilson

### **Governor's Pension Commission for Reducing Pension Costs**

The Pension Commission met on January 7, 2005 and tentatively approved six changes.

The first four changes below apply to <u>new hires only</u>.

- 1. Change the annual COLA adjustment to 2.0% rather than 3%.
- 2. Eliminate the money purchase formula.
- 3. Change the date at which unreduced retirement benefits are first available for new hires to the earlier of age 65 with 8 years of service OR the Rule of 85 (age + years of service = 85 or more).
- 4. Provide the special risk benefit (alternative formula) only to those licensed to carry firearms in their State employment and increase employee contributions.

Two of the changes apply to <u>current</u> <u>participants and new hires</u>.

- 1. Increase the employee contribution rate by 1% for all participants, but do not consider such additional contributions for the money purchase benefit
- 2. The cost of any increase in pension benefits as a result of annual increases in pay that occur during the final average period that are in excess of 5% will be funded by the entity (i.e., school district, university, etc.) responsible for the pay increase.

At the January 14 meeting the Commission discussed fine-tuning the six recommendations tentatively approved on January 7 and added four new items for consideration.

- 1. Define the rate of interest applied to the money purchase option by State statute. Currently the SURS Board (appointed by the Governor) designates the rate each year.
- 2. No new pension benefits will be adopted without first finding a source for funding.
- 3. The 1995 funding plan for pensions might be revisited and revised.
- 4. Borrowing for additional Pension Obligation Bonds will be explored.

The Pension Commission has held all their meetings in Chicago, which makes it difficult for people downstate to attend (especially if they are down as far as Carbondale). Their recommendations seem rather confusing. Several people on the Commission think that the State pension is an addition to Social Security benefits. They do not realize that many SURS retirees do not get Social Security

and those that do have a 50% - 60% reduction because of the so-called Windfall Elimination Provision.

The Commission or someone (such as the Illinois Board of Higher Education) also needs to consider the impact of a two-tier pension system on the hiring, morale, and retention of new, well-qualified employees. On the good side, while the Commission played with ideas to cut pensions for current retirees, as of 1/16/05 there are no proposals on the table to do so.

The Governor's Pension Commission is scheduled to report in February. Please remember that all of these proposed changes are tentative until the final report is done. At that time many of the changes will require revisions in law by the legislature and Governor.

#### Senator Winkel's Alternative to House Bill 750 and Senate Amendments

The November 1 ISUAA Newsletter contained information on House Bill 750 (HB750). Now, Senator Rich Winkel (Urbana), formerly a main supporter of HB750, has backed off and is proposing his own plan. It would raise the state's individual income tax rate from 3 percent to 4.75 percent. The corporate rate would increase from 4.8 percent to 7.6 percent. The tax rate increases would yield an estimated \$4.9 billion more per year in State revenue. It would not tax pensions or impose a sales tax on services, which are included in HB750.

Most of the revenue in Winkel's plan would go to three places:

1. A reimbursement to property taxpayers of 20 percent of the amount they pay to support schools (cost estimated at \$2.4 billion).

- 2. A raise in the school funding "foundation" level by about \$1,000 per student for the most property-poor school districts (cost estimated at \$1.8 billion).
- 3. \$500 million for higher education.
- 4. The remaining \$200 million is uncommitted. As noted in the last newsletter, HB750 provides \$2 billion in uncommitted money to be used as the Governor and Legislature want.

The increase for higher education is not included in HB750. Winkel would try to assure that the \$500 million would be an additional amount to the regular appropriation for State universities and public community colleges. The idea is to avoid what happened with the Illinois lottery, which was supposed to help fund the public schools. Contrary to popular thinking, after expenses are paid the lottery does not produce much money. While some money gets to the schools, the general State appropriation for schools has been reduced by about the amount they receive from the lottery.

### IRS DEDUCTION FOR STATE SALES TAX

If you itemize deductions on your federal taxes, or are close to being eligible to do so, you should take a close look at the new provision for '04 taxes that allows you to claim state sales tax as an alternative to state income tax. This is especially relevant for annuitants when much of our income comes from annuities, pensions, etc not taxed as income by Illinois. For more

### GOOD NEWS—NO DUES INCREASE

The ISUAA Board of Directors met January 12 for the specific purpose of reviewing chapter finances and to consider an increase in dues. As recent as November it appeared that a significant dues increase in 06-07 was likely (and possibly needed earlier than 06-07). Based on projections reviewed 1/12 the Board feels the increase may not be necessary. One major factor is University Advancement Services sponsorship of the ISUAA Directory. That began this year and is expected to continue. Another is the belief that some budget expense lines can be reduced with minimal impact on the Board's ability to advocate the interests of ISUAA members. It also helps that ISUAA reserve funds are healthy enough to absorb some budget deficits. It appears that a dues increase will not be recommended until reserves are projected to fall to below an acceptable level. Many ISUAA members could easily afford a \$3 - \$4 dues increase and may wonder why so much effort is spent agonizing over this, but there are other members for whom an increase could pose a hardship and the Board wants to delay that from happening as long as reasonably possible. The Board will continue to closely monitor finances and hopefully be able to avoid increasing dues for a couple of years.

### SAVE A FEW TREES Automatic Dues Deduction

ISUAA Automatic Dues Deduction saves trees and money. Thank you to those members who are having ISUAA/SUAA dues automatically deducted monthly from their SURS annuity via automatic dues deduction (DD). DD is available only to retirees receiving a SURS annuity and amounts to \$2.08/month (\$3.83 w/spouse). It's convenient for those of you on DD and it saves ISUAA/SUAA time as well as paper, printing and postage expense. If you are on DD you don't have to worry about receiving, completing and mailing a renewal form as you will be automatically renewed unless you contact SURS to cancel. You can tell if you're on DD by looking at the mailing label on your "isuaa news." Just above and to the left of your name there will be "DD" and the date your dues deduction was initially confirmed, such as "DD0704." The State Universities Annuitants Association (SUAA) will mail renewal forms in late spring to most members who paid their 2004-05 dues by check. If you are among this group please consider DD at renewal time. Currently ISUAA has some 30% of members paying via DD. Statewide the percentage is close to 40% and NIU is near 60%. We'd like to close that gap and save some expenses. Whether you renew by DD or check, when you renew promptly it reduces the need for followup mailings. Your membership is too important for ISUAA/SUAA to give up after one mailing. A new membership wrinkle just enacted by SUAA is that new members whose forms/checks for single cash payment were received by SUAA after 1/1/05 will be on a calendar

year membership for one year from the date their membership was recorded.

## CAREMARK – PRESCRIPTION DRUG PROGRAM Yvonne M. Hougham

In December, you received the latest information about your prescriptions. You have two options:

- 1. Their mail order plan for which you received information and forms that outline steps to follow.
- 2. Continue with your present pharmacy. As of their letter, the local pharmacy that will continue to service the State of Illinois plan is Osco Drugs. However, other pharmacies might agree and you should inquire if they plan to participate in the State of Illinois Drug Program. If not, you have a choice between the two options currently.

You received two new Caremark ID cards in December. You should be sure to show your new card and number to your pharmacy, as your S.S. number has been omitted and a new number identifies you as a member of the State of Illinois Drug Program. If you have further questions about the drug program, you may call 1-800-2321-4403.

#### HOME DELIVERY SERVICE

If you cannot visit the library because of a temporary or permanent illness or disability and are a Bloomington resident, you are eligible for Bloomington Public Library's Home Delivery Service. If you reside in Golden Prairie Public Library District (GPPLD), see our Books-By-Mail Service.

Materials available for delivery include books, large print books, magazines, videos & DVDs, and books on tape & CD. A library staff member or volunteer will deliver the materials to your home on a specified day every other week. The Home Delivery Service Coordinator will take your application over the phone or in person. Materials will be selected for you based on your reading interests and special needs. You do not need a library card to be eligible for this service. If you have any questions, please e-mail the Outreach Department or phone 828-6091 Ext 221.

The Normal Public Library also offers this service but information about it does not appear on their website. Call the Normal Public Library for information.
