Convert to dues deduction and save ISUAA money

Thank you to those who utilize automatic dues deduction (dd) or ISU payroll deduction (pd) to pay their ISUAA/SUAA dues. We also appreciate those who pay by check and do so promptly. We appreciate all members, even those who are tardy in their renewals, but it has become increasingly obvious since these automatic deduction plans have been implemented that these methods of dues payments save us money as well as time.

While a number of members have converted, we still have less than half using this convenient form of payment. We would like to significantly increase that. We believe it is a plan worth investing in and thought about having a drawing with monetary prizes for those who convert but had second thoughts. Instead we thought we'd appeal to members to convert to help us save money/time, and for their own convenience. Let's face it; we all get a lot of mail and it is just too easy to toss it aside thinking we'll deal with it later.

Acknowledging that some annuitants are reluctant to put their full Social Security number on forms, the requirement for dd has been changed. Only the last 4 digits are required. Also, even if your single pay membership will not expire for months you can file a dd form now and conversion to dd will take effect when your single pay membership expires. Another new provision is that those still working for the University who are on payroll deduction can complete form #3 now and automatically convert to dd from their monthly SURS pension when they retire

Founders Day

Illinois State University's year-long sesquicentennial celebration will conclude with activities on Founders Day, February 14, 2008. The convocation begins at 1 p.m. in Braden Auditorium, Bone Student Center.

In addition to the presentation of various faculty and staff awards, the convocation address will be given by Ray Kurzweil,

widely regarded as one of the leading inventors of our time. Kurzweil was the principal developer of the first omnifont optical character recognition (OCR), along with the first print-to-speech reading machine for the blind, CCD flat-bed scanner, text-to-speech synthesizer, music synthesizer capable of recreating the grand piano and other orchestral instruments, and the first commercially marketed, large-vocabulary speech recognition system.



In addition, Kurzweil has written five books and hundreds of articles. In the year 2001, there were over 200 articles by or about Ray Kurzweil in leading publications, including most major national magazines. His first book, The Age of Intelligent Machines, was named Best Computer Science Book of 1990. Written in the late 1980s, it's been acclaimed for its remarkably accurate predictions about the 1990s and early 2000 years.

A public reception in the Brown Ballroom will follow convocation.

Other activities include the Founders Day Old Main Bell Ceremony, which begins at 10 a.m. in the Brown Ballroom. A public reception follows from 11 a.m. to 12:30 p.m. in the ballroom. Exhibits of various campus units and departments will be open throughout the day there.

The Helping Hamper recipient for the March luncheon will be the Compassion Center, a daytime shelter for the homeless. They can use individual snacks including high protein bars, microwaveable single serving meals, coffee and tea, paper cups and napkins, cold medicine, facial & toilet tissue and laundry detergent.

Also, starting with the March luncheon we will start helping Thomas Metcalf School by collecting proofs of purchase called "Box Tops for Education." These are on standard household products and can be exchanged by Metcalf for cash or school supplies such as printers, digital cameras, cafeteria tables and a climbing wall for the gym. The rectangular "Box Tops" tokens are printed on the edge of the packaging where it won't distract the buyer from product information. These are smaller than a postage stamp in size. 

SUAA fall 2007 meeting summary

The SUAA Board of Directors met October 10, 2007, in Urbana. Representatives from throughout the state attended, including Janet Cook, Richard Dammers, Robert Hunt and Christ Schwelle from ISUAA.

SUAA finished 06-07 in the black financially, but is budgeted to experience a slight net operating loss in 07-08. There are sufficient reserves to cover the loss and hopefully, membership will increase significantly and help offset that. The SUAA membership committee, which includes Janet Cook, shared ideas for increasing membership.

The agenda also included approval of SUAA's legislative goals with a general focus on maintaining the integrity of the State Universities Retirement System (SURS) for present and future annuitants and survivors. The goals are:

- Develop SUAA positions on budgetary reform and/or revenue enhancement proposals that might be considered in the forthcoming session of the General Assembly.
- 2) Maintain health benefits offered through the state employees group health plan and the college insurance plan.
- Continue to monitor progress of current WEP/GPO repeal legislation. Issue Legislative Alerts, as appropriate.
- 4) Monitor the implementation of the GASB 45 accounting guidelines in the discussion of pension and health benefits issues in the General Assembly or by the governor or other members of the executive branch.
- 5) Support SURS legislation to restore the two-year sick leave credit option for those retiring under the years of service option for members in universities and community colleges, the increase of the death benefit from \$1,000 to \$5,000, and other SURS legislative proposals.
- 6) Develop a legislative call to action network of Chapter Legislative Chairs who will advise chapter members when to contact their representatives concerning pending legislation.
- Continue to review developments regarding the convocation of an Illinois Constitutional Convention.

SUAAction, SUAA's political involvement committee, reported that 12 chapters, including ISUAA, exceeded their fundraising goals. SUAAction carries a balance of \$113,700 into 07-08. As of October 10, 2007, funds have been disbursed for SUAAction representatives to attend fundraisers for eight legislators. It was noted that these fundraisers typically provide the opportunity for contact with more legislators than the one for whom the fundraiser is being held. ISUAA's Christ Schwelle is the SUAAction treasurer.

Dick Lockhart was introduced as the new ISUAA lobbyist. Lockhart has extensive lobbying experience in Illinois and shared his philosophy and thoughts on lobbying. He discussed the likelihood of a Constitutional Convention. At this point he believes there are powerful interests that would oppose a Con Con, but continued negative perception of state government could influence voters to think constitutional change is needed.

Dan Slack, executive director of SURS, presented information on SURS, including a profile of participants and current financial information. This will hopefully appear in the SURS newsletter. Slack said legislators seemed to get the message that they could not fund pensions in an amount less than what was called for as this year's payment, but of course catch-up is also needed. Slack pointed out that '09 and '10 are crucial years in getting close to getting on track. Unfortunately the end of '08 is when the unfunded liability for retiree health costs, as well as pension liability, will be reported (GASB 45). That will be a major political issue at a time when a vote on convening a Con Con could be approaching—with an opportunity to open the door on the constitutional provision protecting pensions. We still believe, even in a worsecase scenario, the pensions of those already retired, and probably those already in the system, are protected, but we prefer to avoid going to court. We have an obligation to help public higher education stay competitive as it competes for future faculty and staff. Retiree health benefits do not have the same protection and we have no report on how those negotiations between AFSCME and the state are going. The consensus on the ride home was that SURS participants are fortunate to have Slack as executive director.

Information from the Illinois Retirement Initiative was shared with attendees. A number of state employee retiree organizations, including SUAA, are endorsing

organizations and ISUAA Executive Director Linda
Brookhart regularly attends the meetings. The Steering
Committee includes the Center for Tax and Budget
Accountability, AFSCME Council 31, IEA, IFT and Service
Employee International Union Local 73. Points made
included that the pension crisis in Illinois is not a fault
of the pension systems, but of the state's failure to fund
its obligations and switching from a defined benefit plan
to defined payment is not the answer for a variety of
reasons, including administrative costs of defined
contribution plans.

Social Security offsets were addressed by Dr. Jeff Brown, UIUC finance professor and recognized authority on Social Security. Brown provided information on why the offsets were enacted, the significant challenges in trying to repeal them and possible alternatives on pursuing modifying the formulas to lessen the adverse impact for those receiving both Social Security and public pensions. Brown noted that Illinois is one of only seven states that opted not to participate in Social Security. Brown's presentation was sobering relative to the likelihood of eliminating offsets, but gave hope relative to possible modification of the formulas. Informal discussions held subsequent to the fall meeting indicate that SUAA will likely continue to support repeal of the offsets.

This was an informative meeting and an important one for your representatives to attend.

The ISUAA Survivor Advocacy Team has decided that because of the common questions they receive after the death of annuitants and the grief that surrounds such a loss, it would be a good idea to host educational sessions in advance for possible survivors. The focus will primarily be on SURS requirements and procedures. A checklist will be distributed and discussed. The format will be small group presentations and discussions led by Advocacy Team members

The groups will be limited to 12 for each session and advance registration is required. Both the annuitant and the potential survivor should attend. The sessions will take place in the Spotlight Room of Bone Student Center (1st floor across from Circus Room), 12:30-2 p.m. on: Thursday, March 20, Thursday, April 24, Wednesday, April 9 and Thursday, May 15.
