TechZone can help you purchase everything from complete computer systems to printer ink. TechZone offers the flexibility of shopping online from home or working with friendly staff for personal assistance through the buying process.

TechZone keeps some of the most popular computers, iPods, and cables in stock while other models can be specially configured and ordered online. Vendor partners include Apple, Dell, Lenovo/IBM, as well as numerous other sources for peripherals. All vendors meet high standards for competitive pricing, quality products, customer service, warranty, and repair.

#### **SUAA** briefings

Many of us with accurate e-mail addresses on file with the State Universities Annuitants Association receive e-mail "Briefings" and "Mini-Briefings" from SUAA. For those who do not get these, here are some tidbits gleaned from these briefings:

**Pension funding**—The selling of bonds to fund state pensions has been delayed. Selling bonds for this purpose and/or for paying the state's bills, rather than increasing revenue, just means more debt for Illinois. This should not impact the payment of pension benefits to annuitants as required by law.

Pension Modernization Task Force—The state's Pension Modernization Task Force could not agree on the content of its final report. One point of contention was that some Task Force members did not want it reported that the cost to taxpayers of state-funded pension benefits is less than the cost in the private sector and neighboring states. Also, changes or cuts in pensions of future employees will not reduce the state's debt for past benefits already earned, nor lower required pension payments in the near term. The private sector representatives seem to be intent on changing public pensions for new employees, and if they can find a way legally, current employees. Current annuitants seem to be safe from the changes being discussed.

**Dental insurance premiums**—An arbitrator has rejected a grievance filed by AFSCME challenging the state's imposition of an \$11 per month retiree contribution for dental insurance. AFSC-ME has indicated they were reviewing the decision and assessing options that might be available.

**Health care claims**—Payment of these is still very slow. If things get really bad SUAA suggests calling Jay Brown at the Governor's Office (866) 465-9889.

**National health care reform**—This will most likely not affect those on the state health insurance program.

#### SUAA fall meeting/dues increase

The SUAA Board of Directors met October 5, 2009, in Urbana. Delegates from ISUAA were Larry Alferink, Jan Cook, and Dave Wiant. Legislators from the area briefed the group about the state fiscal situation. Dave Wiant addressed the group about the need for SUAA members/chapters to let legislators know we are disappointed with the lack of action on their part regarding the state's fiscal crisis.

The SUAA board of directors approved a \$4 annual increase in SUAA dues, from \$21 to \$25 effective January 1, 2010. ISUAA local dues will remain at \$4, with a local dues waiver for spouses. The total annual dues for ISUAA members will be \$29 (from \$25) for the retiree and \$25 (from \$21) for spouse members. Those who pay dues via check will see the increase when they renew. Those who pay via dues deduction will see a very small monthly increase. The dues increase is needed to adequately finance the SUAA Office in Springfield. The SUAA Office has been taking an increasingly active and important role in advocating on behalf of members. It was felt that now is not the time to adversely impact their ability to function effectively.

#### Social Security/Medicare for SURS members

Approximately 80 people attended the Social Security/Medicare for SURS members program on October 27, 2009, featuring Elaine Popejoy of the local Social Security Office. More information is available on the Social Security Web site, including a benefits calculator for those affected by the Windfall Elimination Provision, which impacts those eligible for both Social Security benefits and a SURS (or TRS) pension. ISUAA will be repeating this program on April 8. Publicity will be in *The Report*, Illinois State's faculty-staff newsletter.

#### **Government Retiree Credit**

According to IRS instructions that accompanied US 1040 forms, you may be able to take a Government Retiree Credit, "if you received a pension or annuity payment in 2009 for service performed for the U.S. Government or any state or local government (or any agency of one or more of these) and the service was not covered by social security. The credit is \$250 (\$500 if married filing jointly and both you and your spouse received a qualifying pension or annuity)." Be sure to consider this when preparing your federal tax return.

#### **Planned giving**

Gifting appreciated securities may be a viable option for many donors. Stocks that have been held for several years may have market values that are considerably higher than the donor's purchase price. When appreciated securities are gifted to the Illinois State University Foundation, the donor is credited with the fair market value on the date of the transfer of the securities. And, because the foundation is a tax-exempt entity, no taxable capital gains will accrue to the donor or the foundation. #### **Legislative update**

Christ Schwelle wrote local legislators expressing disappointment with the lack of serious attention to the state's fiscal crisis, specifically citing the dental insurance premium for retirees and delays in paying medical providers. Dave Wiant, Parker Lawlis, and Schwelle followed up by attending fundraisers for Sen. Dan Rutherford and Rep. Dan Brady. The objective was to let them know we're concerned and watching. Participation in these fundraisers was paid for by SUAAction, SUAA's political action committee. This winter you will be getting a letter from Lawlis requesting that you contribute to SUAAction to help support such activity statewide.

Statewide, public pensions continue to be relatively secure because of the constitutional protection, but we cannot be smug about this. Public pensions and retiree health benefits are clearly in the crosshairs of the private sector, the media, the public, and politicians.

#### How time flies, December-February

#### 50 years ago, 1959

- The Teachers College Board approved \$1.5 million for a new Physical Education Building and Fieldhouse (Horton), \$1.4 million for a Science Building annex, and approximately \$600,000 for expansion and improvement of the University Farm.
- Smith Hall was demolished to make way for the planned 10-story women's residence hall (Atkin-Colby).
- The Illinois State men's basketball team won the IIAC championship (in March) with a record of 20–4. James Collie was named Coach of the Year.

#### 25 years ago, 1984

- December 1983, the Women's Volleyball team went to the first round of the NCAA.
- January 1984, Illinois State women's basketball defeated Bradley in their first meeting (105–52).
- Women's track team won their fifth consecutive Gateway Collegiate Conference championship with six first place winners.
- Two wrestlers qualified for the NCAA national tournament.
- February 1984, President Watkins told the Board of Regents that Illinois State spent \$300,000 for computers in Milner, Applied Computer Science, and other areas of campus.
- March 1, 1984, David Strand formally became the provost.

#### 15 years ago, 1994

- The proposed science building (\$29.2 million) was ranked eighth on the IBHE list of capital improvements listed for Fiscal Year 1995.
- Distinguished alums visited campus to talk on the theme of "In pursuit of a New World Order" and meet with students in politics and government classes. Donald McHenry received an honorary Doctor of Laws degree from the University in 1980, and received Distinguished Alumni Award in 1990.
- The PQP process was moving forward as was the search for a new provost to replace David Strand, who returned to his position as vice president for business and finance.

#### 10 years ago, 1999

- An agreement was reached for Mennonite College of Nursing to become Illinois State University's sixth college and first professional program on July 1, 1999.
- President David Strand received an honorary doctorate from Srinakharinwirot University in Thailand.
- Victor John Boschini, Jr. was named the 16th president of Illinois State University. His term began July 1, 1999. Boschini had been vice president and dean of Student Affairs at Illinois State since 1997.
- Jill Hutchison, head women's basketball coach for 28 years, announced her retirement. With a record of 461–323, Hutchison's teams made a dozen national tournament appearances. She also coached successfully at the international level.
