President's message



Weibring Golf Club at Illinois State University

The Weibring Golf Club at Illinois State University provides golfers of all ages and skill levels a challenge on its tree-lined, 6,730-yard, par-71 course. Open to the general public as well as members of the campus community, the Weibring Golf Club also invites annuitant members to test their skills at one of the most beautiful facilities on campus.

All Illinois State Annuitant Association members receive a discount of nearly 20 percent off the regular rates. For only \$19, retirees can enjoy a round of golf on weekdays, and \$22 for weekends. With a cart, golfers can hit the course on the weekday special for \$25.

Season passes and frequent player cards are an excellent choice for the avid retiree golfer with rates as low as \$640 for an unlimited season pass or \$440 for a weekday pass. As a special offer, annuitants are eligible to receive one special nine hole card that includes 10 rounds of golf for \$60. Members can add a nine hole golf cart to the special for an additional \$63.

A good source for information regarding the program and services the Weibring Golf Club has to offer is the course Web site, www.isugolf.com. By registering online, golfers will receive a free round on their birthday and a monthly newsletter, as well as receive advanced notice of other golf and merchandise specials.

One specific program offered to Illinois State Retirees is the "Tee-Bird Golf League." The "Tee-Birds" are a group of retired ISU faculty and staff and their spouses that play nine holes every week. New members are always welcome and skill level is never an issue. League play begins at 8 a.m. on Thursday May 15. Legislative scene

As the deadline for this newsletter approached, there was not much new to report relative to the status of retirement benefits. SUAA continues to increase its visibility with legislators as SUAA Executive Director Linda Brookhart and lobbyist Dick Lockhart visit with legislators. Brookhart has also been cultivating relationships with representatives of other state retirees/employee groups.

SUAA chapter representatives statewide have been attending fundraisers and other political events. Attending such events frequently allows interaction with legislators other than the one benefiting directly from/sponsoring the event. SUAAction, SUAA's political action committee, now covers the cost of this. This has resulted in a SUAA presence at many more of these events. Among the fundraising events attended were ones for Sen. Emil Jones and Rep. Michael Madigan.

As one listens to legislators discuss state pensions there is now the acknowledgment that these pensions are constitutional obligations that cannot be ignored. In fact after the governor's State of State message one legislative leader stated that while many may not like it, the pensions are constitutionally protected and must be funded. This understanding seems much more widespread than it did a few years ago.

A major concern at this point is that some interest groups will push for a state Constitutional Convention (Con-Con) to void the constitutional obligation relative to state pensions. This is something that SUAA and others representing state retirees and employees are watching carefully. Whether or not to call for a Con-Con will be on the November ballot. A Con-Con could achieve some positive things for the citizens of Illinois, but the potential threat to state pensions makes the risk too great. It's too bad, but that's reality based on experience with politics. That said, many believe that voiding the obligation could be successfully challenged legally on behalf of current annuitants and employees currently participating in SURS, TRS, etc. However, any such threat needs to be headed off at the earliest possible point.

Many may not be aware that our colleagues from state community colleges, while members of SURS, do not have the same health benefits. This is a result of their being employees of local districts rather than "the state." They are covered by the College Insurance Program (CIP), which is a state fund that is "financially challenged." SUAA is supporting bills to improve the viability of CIP. The bills are SB 2595 and HB 5361.

SB2288 is the new "tax swap" legislation, which would increase the state income tax rate in exchange for property tax relief. One of the co-sponsors is Senate President Emil Jones, who opposed last year's tax swap efforts. This piece of legislation will be closely watched as will other bills with potential impact on SURS members.

SUAAction continues to evolve as the group responsible for collecting voluntary donations and distributing funds for political purposes on behalf of SUAA members. A particular legislator or candidate's support of the interests of SURS participants, or position to successfully support such interests, is the most important criteria for SUAAction support – far more important than their other political stances. ISUAA's Christ Schwelle continues to serve on the SUAAction's board of directors. As cited earlier, SUAAction is now actively funding political activity on behalf of SUAA members.

Relative to Social Security offset penalties, Bob Hunt continues to head the ISUAA interest group. Members have been communicating with members of Congress citing how these penalties affect them personally.

FAQ on planned giving

Planned giving to Illinois State can take several forms: Life insurance, bequests, trusts, and annuities, to name a few. Some planned giving options can provide a gift to the University and a stream of income to you. A charitable gift annuity pays you a fixed dollar amount each year for the rest of your life. You receive a guaranteed annual payment no matter what happens to investment markets or interest rates.

There may be significant tax advantages when you set up a charitable gift annuity. A portion of the value of the transaction is considered a charitable gift, which may be deductible from your adjusted gross income. If you use appreciated property to fund a gift annuity, you can avoid paying capital gains tax on the charitable gift portion of the transaction. The remaining gain will be apportioned over your lifetime. Learn more about charitable gift annuities and other planned giving options by calling (309) 438-7681. Did you know?

- Once you retire your "insurance representative" changes from the benefits area at ISU Human Resources to SURS (1-800-275-7877 ext. 0).
- Illinois State offers free tuition and fee waivers for retirees (up to eight hours per semester).
 Individuals have to meet entrance requirements.
 Contact Admissions at 438-2181 to begin the process.
- ISU retiree photo IDs allow free access to BN Public Transit fixed bus routes. If you do not have such an ID, contact the Redbird Card Office, 438-2273, to learn how to get one. This card opens the door for all kinds of privileges. Cards are available to survivors.
- The emeritus/retiree parking tag (gold) you have is good for another year if it is shaped like the state of Illinois. The rectangular tags expire this summer. Parking Services plans to start distributing new tags mid–late July. They ask that people bring their emeritus/retiree photo ID card and suggest watching their web site or calling (309) 438-8391 if you have questions. This tag allows for free parking in Illinois State University pay lots except when a special event rate is in effect.
- The Illinois State University retiree ID card allows both the retiree and spouse access to Milner Library privileges. This could be a good alternative to the Normal Public Library if you can't find parking there.
- The "panic/emergency" button on the key fob for your car can have a long range, perhaps enough to keep at your bedside so that if you have an emergency at night you can set off the car horn and attract the attention of neighbors or scare off a potential intruder.

Programs on survivor planning popular

On February 21, the ISUAA Survivor Advocacy Team had their first educational session for possible survivors. The team had decided that, because of the common questions they receive after the death of annuitants and the grief that surrounds such a loss, it would be a good idea to host educational sessions in advance for possible survivors. Five couples and two individuals attended the session led by team members Mary Liverman and Edna Johnston.

After some opening comments by Mary and Edna, the bulk of the session was devoted to reviewing copies of actual sample letters and forms mailed to survivors by SURS, and relative to insurance, Central Management Services. These were part of each packet distributed. Mary and Edna took attendees through each document and attendees asked questions and took notes on the letters/forms so that when the time comes they will be better prepared to promptly meet the requirements necessary to obtain survivors' annuities and insurance coverage.

Among the specific topics discussed was the wisdom of obtaining an adequate number of certified death certificates for SURS, insurance companies, banks, 403b/IRA firms, vehicles and other property transfers, etc. These certified death certificates are less expensive and more convenient to obtain from the funeral home at the time arrangements are made. Participants agreed that the material they received and related documents should be kept in one location and their children or others should know where that is.

Additional sessions for different participants were held on March 20 and April 9 and 24.

SUAA spring meeting summary

The State Universities Annuitants Association board of directors spring meeting was held in Carbondale March 12. Illinois State chapter delegates attending were Jan Cook and Paul Schertz.

The lead topic was the 2008 Constitutional Convention Referendum (see article on legislative scene). Dick Lockhart, SUAA's lobbyist, and Linda Brookhart, SUAA executive director, addressed this topic in detail. Lockhart also updated delegates regarding new legislation of interest, which is at the early stages of the legislative process and being analyzed by Lockhart, Brookhart and SUAA's legislative committee.

Various association reports were also given. When the report on membership was given the Illinois State chapter was acknowledged for being a model of membership recruitment and stability, consistently enrolling more than half the retirees as members.
