#### SURS NEWS Jan Cook

Mid-October pension news from Springfield centers on the search for a new director for SURS. The Pantagraph reported on the Governor's nominee in an editorial many of us read. SUAA Director Don Naylor tells us that the Search Committee appointed by the SURS Board already had identified at least three candidates with solid qualifications in retirement systems before the Governor's suggestion was published. There has been no deadline set for the search. If you subscribe to SUAA's list serve or monitor the news on their web site, you will be getting updates on the progress of the search. Annuitants really do care about the qualifications of the person chosen to manage our pension funds.

#### A MESSAGE FROM ILLINOIS STATE'S NEW ATHLETIC DIRECTOR Sheahon Zenger, Illinois State University Director of Athletics

Dear Illinois State Annuitants,

Upon taking the job as director of athletics at Illinois State University, a question I am often asked is, "Why Illinois State?" My response has been, "Why NOT Illinois State?" An answer I'm sure with which all of you can agree. After all, if you talk to anybody in the real estate business, the value of property all comes down to location, location, location. It didn't take me long to realize that Illinois State University has the location. We are only two hours from Chicago, two and a half from St. Louis and three hours from Indianapolis.
