# **SUAA** annual meeting summary

Delegates from ISUAA Jan Cook, Richard Dammers, Paul Schertz, and Chuck Taylor attended the State University Annuitants Association (SUAA) annual meeting in Springfield June 17 and 18. Chapters from throughout the state were represented. Among the speakers were State Comptroller Dan Hynes, SURS Executive Director Dan Slack, and Bernard Schoenburg, political columnist for the *State Journal Register*. In a nutshell, the state is in a financial and political mess. Fortunately the state is legally obligated to pay state pensions. SUAA contract lobbyist Dick Lockhart moderated a panel discussion on the issue of a constitutional convention that featured two proponents and two opponents. (In the summer newsletter it was mentioned that SUAA is among those on record as opposing "con con" because of its potential negative impact on SURS members and the fact that constitutional issues can be dealt with via the normal legislative process.)

SUAA's annual business meeting was conducted. Richard Johnson (UIC) was elected president, Pat Smith (Kishwaukee College) was elected treasurer, and SUAA's budget for 2008–2009 was approved.

ISUAA was recognized for the continuing growth in membership and having a membership count of some 61 percent of those eligible. ISUAA's 1,378 members were fourth behind UIUC (2,083), NIU (1,772), and UIC (1,641). Total SUAA membership was reported as some 14,800.

For the first time in many years, there will be a special program to ask current University employees, retirees, and survivors to make the University a part of their annual philanthropy plans.

Many current employees, retirees, and survivors are already regular and generous donors. The goal is to increase the number of such donors. The percentage of current employee, retiree, and survivor donors can be a key factor in convincing others to donate.

The "Gladly We. . .Faculty/Staff/Retiree/Survivor Annual Fund" will be formally launched on February 2. With an ultimate goal of 50 percent of current and retired employees as annual donors to the University, February and March will be focused on acquiring new donors. All faculty/staff/retiree/survivor donors who contribute a minimum of \$10 during the 2009 fiscal year will be counted. Donors will be asked to contribute to the campus areas of their interest including academic departments, WGLT, Athletics, laboratory schools, and scholarship funds.

# **Gifting options**

As we approach the end of 2008 it is a good time to consider ways that you may wish to continue making a difference to Illinois State University and the students it serves.

Gifting options can be immediate or deferred. Immediate gifts include cash, marketable securities, or other tangible personal property that can be readily turned into cash or used by the University. Such gifts made by December 31 entitle the donor to a charitable gift deduction on their 2008 tax return. Gifts made with a credit card by December 31 can be deductible in 2008 even though payment to the credit card company may not be made until later.

Deferred gift commitments may take many forms including life insurance policies, charitable gift annuities, retirement account balances, and a number of other options.

Some changes have been made in how ISUAA works on behalf of members relative to legislative issues. # Phishing: Don't be the bait

Phishing is the criminally fraudulent process of attempting to acquire sensitive information such as user names, passwords, and credit card information by masquerading as a trustworthy entity via e-mail, phone, or text message.

How do I tell if an e-mail is fraudulent? Here are a few phrases to look for if you think an e-mail message is fraudulent.

- Verify your account
- If you do not respond within (specified time) your account will be closed
- Dear Valued Customer
- Click on the link below to gain access to your account
- Fill out our survey for \$\$\$\$

Phishers tend to use emotional language as scare tactics or urgent requests such as those listed above to entice recipients to respond. However, no legitimate institution will ever ask you to verify information unless at your request or initiation. If you feel that your personal account information has been compromised, you should contact your financial institution immediately.

# Your money is insured

Illinois State University Credit Union is a state-chartered financial institution, insured by the federal government agency, the National Credit Union Administration (NCUA). Recently there has been discussion on the safety of deposits; rest assured that your deposits are safe up to \$100,000 per account, with additional coverage up to \$250,000 for retirement accounts. # **Health benefits**

In the previous issue of the newsletter it was mentioned that the negotiations of health benefits between the state and AFSCME had been described as contentious as the state was under pressure to cut back on these expenses. It was acknowledged that AFSCME was advocating on behalf of their members and the rest of us.

About the time articles were being prepared for this issue of the newsletter, the state and AFSCME reached agreement on a contract and it was ratified by union membership. AFSCME reported to their members that they negotiated an agreement that, "fully preserves the current framework for retiree health benefits." Available details were shared with your ISUAA Board of Directors, but the official word will come from Central Management Services (CMS). This comes in the form of a booklet describing the changes and detailing new premiums, deductibles, co-pays, etc. It is not known when it will be mailed, but you are urged to review it carefully.

If you believe your health benefits were fully or essentially preserved, great! However, let's not gloat about it as many are losing ground relative to health benefits. Do not feel guilty either. You are getting, "what you signed up for," and what you earned as part of your compensation package during your years of service to the State of Illinois.

# **Chapter directory**

Work is currently underway to put together the ISUAA directory for 2008–2009. Jude Boyer and Dona Meador are coordinating this project. Every effort is being made to be certain the information is accurate and up-to-date. With 1,400 members in the chapter, this is a major task. # **How time flies**

10 years ago • September-November 1998

September 25, 1998

The bell from the tower of the Old Main building is rededicated on the university quad and rung for the first time in 30 years at Homecoming. The original bell cracked and had to be removed in spring 1880. An Ohio company made a new bell for a net cost of \$139.93 including installation in January 1883. The second bell was removed from Old Main in the spring of 1946 when the third floor and tower were designated as structurally unsafe.

1998 fall enrollment was 20,105

15 years ago • September-November 1993

The legislature appropriated \$104.16 million (up 3.7 percent) for Illinois State University.

Grants and contracts totaled \$8.9 million 13,411 donors gave \$5.3 million.

The University acquired three vehicles that had been modified to run on up to 85 percent ethanol.

25 years ago • September-November 1983

Enrollment (on- and off-campus) reached 20,662

Grants exceeded two million dollars in support of 94 proposals.

In fall 1983 the University was gradually climbing out of the fiscal crisis in the state that had begun in 1981. The University had suffered rescission, the loss of a summer session, unfilled positions, shortages of classes, and declining morale.

#### 50 years ago

As the centennial was moving toward completion 15,000 red tulips and 8,000 white tulips were being planted in the ground where Old Main stood.

Enrollment reached 3,570 resident students representing 94 counties, 28 other states, and 11 countries and territories.

Grants of \$2,740 were received by nine faculty members.
